Committee Chair Pledges More Scrutiny to Budgetary Items

The Hudson Budget Committee met on May 1 to at what Hudson's upcoming budget might look like, starting with what might be done with money not specifically allocated to a department.

"One item I'm interested in and I think the Committee is across the board, is the unexpended funds, what I call the rainy day fund. I believe right now the town's fund is in the \$7.3 million range," said Budget Chair, Bill Cole, who hoped to learn what the balance might be at the end of the fiscal year.

While no action was immediately taken, he promised to follow up with the matter in the near future. He also promised to look

"I personally, as a member of the Committee, and as a taxpayer, have no idea what the \$85,000 bought," said Cole, referring to the cost of the study. "It's a question I just cannot get an answer to, but I assure you

Member, Shawn Jasper, shared some concerns about the facilities study.

"Not only do I have questions about what that report accomplished, but I think there were misstatements of facts in that report," said Jasper.

According to Budget Clerk, Kevin Walsh, the study was the result of it being "a long time" since

deeper into the School doing a comprehensive study of school building safety.

"There were some safety concerns that were just outlined in that particular study that could and should be addressed for the shortterm," he explained.

The Chair also expressed disappointment there were no liaisons from the School Board or the Board of Selectmen at the meeting, and he looked forward to talking about future funding matters related to the school system in the runup to the start of the next budget season. There was also some concern over a new platform firetruck. There were questions over whether funding for the truck was properly approved by voters.

School Board Review Access to Public School Programs Policy

The Hudson School Board had a first reading for an updated policy related to access to Public School Programs by Non-Public, Charter School, and Home Educated Pupils during its May 6 meeting.

"All pupils residing in the district, whether they are home educated, or are attending public chartered school or nonpublic schools (collectively, "non-enrolled district students"), shall have access to curricular courses and co/extra-curricular programs offered by continued on page 2 with RSA 193:1-c," the proposed policy states.

The proposed policy states that "non-enrolled district students will have the same access as enrolled students to the district's courses and programs. Nonenrolled district students shall not be subject to any policies, procedures or standards with respect to participation in the district's courses or programs that are more restrictive than those governing the district's enrolled students."

The proposed policy states that students not enrolled in the District "must meet the same eligibility criteria as the district's students as described

in paragraph B below."

"The district allows non-enrolled district students to participate on an equal basis in courses and programs offered by the district provided they meet the eligibility requirements for participation (e.g., deadlines for registration, academic progress/performance, parental permission, third party (e.g., NHIAA) requirements, physical exams/health requirements, etc.)," the proposed policy

As part of the proposed policy, it states that "In the event that a course or program has reached capacity,

Budget Committee Vote to Require Request of Earlier Default Budget

The May meeting of the Hudson Budget Committee saw its members discuss rising costs across the Hudson School District. Shawn Jasper proposed looking over recent test scores to see what level of funding might be most appropriate during the next spending cycle.

"What I would like to see is over, I'll say 10 years, somebody might want a different set of years, how we are doing as a district in standardized testing," said Jasper. "If we're adding

more personnel and test scores are going down, and certainly we saw recently that proficiency scores were really terrible in Hudson, I don't know how they are in the rest of the state, is that just COVID?"

Recently, the school district asked for more staff members due to some controversy at previous Budget Committee meetings. There were also worries about the annual tax rate from higher spending.

"I think this is a Budget Committee matter because I think it goes to the citizens

of this town getting the value for their dollar that they're paying in taxes," said member, Kim Rice.

Clerk, Kevin Walsh, suggested that any look at test scores needed a more in-depth look beyond simply looking at the numbers, encouraging the Committee to take factors like age-related test score progression and make-up of the student body into account.

"It's not a simple answer," said Walsh. "There's a lot of great conversation that's going to come out of

this and I think we'll all than what was requested in benefit from that exchange of information."

Budget Chair, Bill Cole, emphasized his stance that if it has to do with a single dollar going in or coming out, it belongs to this Committee." He encouraged members to ask questions about spending items from any Hudson board, committee, or department.

Vice Chair, James Lawrence, moved to how the town and school default budgets submitted to the Budget Committee by July 20, three months earlier 2023, to give the members more time to look at the numbers before the formal budget season.

"The default budget in my mind, should be what your approved spending should be for the previous year, plus whatever contractual obligations you entered into, nothing more," said Lawrence. "If you look at the default budgets we presented to the voters this past go-around, those default budgets had substantial increases over what the budget was for the previous

because we didn't get it in time to scrutinize those default budgets, what calculations went into deriving what that default budget was."

The motion carried unanimously.

"It's only going to get more interesting as we go along this year," said Cole.

The Budget Committee is set to meet again on Wednesday, June 5, at 7 p.m. in the lower-level Buxton Community Development Meeting Room at Town Hall.

continued from page 1 most of his life, and was eventually left on disability with an oxygen machine "connected to him 24/7" as his remaining lung struggled to compensate by age

According to his mother, Jason was always susceptible to illness, including a bout of respiratory syncytial virus and the growing risk from the COVID-19 pandemic, leading to the need for a double lung transplant last New Year's

However, the transplant did not mean an end to ongoing costs related to medication and the need to travel to Massachusetts General in Boston for follow-up appointments, all of which proved expensive.

"Everything's gone," said Caroline, referring to money raised using peerto-peer fundraising through. "They shut down and nobody has access to any of the money."

Caroline accused NFT of hurting the people who claimed to help with their refusal to offer direct access to donations made for a specific patient.

"They're messing up

everybody's lives," said Caroline, adding that NFT never reached out to her.

The Stecchi family still has a GoFundMe page and an account at St. Mary's Bank for donations.

According to the official NFT website, no patient working with the company had any "personal ownership or financial account" related to funds raised and claimed it had "discretionary use to support its mission."

"NFT remains committed to offering support throughout this transition period until April 30th, 2024," the group stated on its FAQ page. "This deadline is crucial for us to efficiently do our best in allocating resources and provide the necessary support. If your grant is approved in whole or in part, you can

expect to receive it in May 2024."

It was unclear how many people who raised money through NFT have received a full or partial grant, nor is it clear what would happen to the remaining funds after the April deadline.

NFT did not respond to a request for more informa-

School Board Send Proposed Expense Reimbursement Policy to Second Reading

The Hudson School Board had a first reading for its expense reimbursement policy during its May 6 meeting.

In March, the School Board rejected a proposed rewrite of the policy with a 3-2 vote.

"We currently have a very different policy than districts around us," Business Administrator, Jen Burk, said at a previous meeting.

She previously explained that when they get employees from other districts, they have some who are confused and possibly concerned "with the board component to this."

Burk explained that traditionally the travel requests

just go up the chain of command to the assistant superintendent or superintendent level, noting that they are part of the budget.

Those who opposed the policy argued there should be some mechanism for the School Board to hear about what happened at the conferences, or other events they traveled to.

However, Burk explained that it was a concern for a number of staff members having to present in front of the School Board saying, "I've had people tell me specifically they felt physically ill having to come to the board to ask to go to a conference."

The proposed policy states "Hudson School District personnel who incur expenses in carrying out

their authorized duties may be reimbursed by the District upon submission of a properly filled out and approved purchase requisition, which must be completed in advance of the expense being incurred, and providing such supporting receipts as required by the Business Administrator."

"Such expenses may be approved and incurred in line with budgetary allocations for the specific type of expense," the proposed policy states.

The proposed policy goes on to state that any employee who wants to request to be reimbursed "for travel expenses incurred under this policy must complete a travel expense reimbursement form, to be submitted along with the pre-approved purchase requisition, all original, itemized, final receipts, and approval confirmations for all expenses, to the SAU Business Office within fifteen (15) days upon returning from the trip."

"Reimbursement travel expenses will only be issued after the employee has completed the trip, and only upon submittal of all items outlined in this policy," the policy states.

The policy also states that all "travel outside of NH, and any in-state travel requiring an overnight stay, must have the prior approval (written or electronic) of the Superintendent or designee, and such approval shall accompany the request for reimburse-

It was noted that they had language added to the proposed policy related to international travel.

"Travel requests for individuals in excess of \$3,000, or requests that would require international travel even if total request is under \$3,000, will also require prior approval by the School Board," the proposed policy states.

The proposed policy also states that "All expense reimbursement forms, and travel expense vouchers must be approved by the employee's supervisor and administrator and must include all associated receipts for requested reimbursement including flights, hotel, meals and other related expenses."

"In the event that reimbursement is being made for multiple employees on a single receipt, the senior supervisor/administrator in the traveling party must charge that expense and submit the receipt for reimbursement in accordance with this policy. Receipts covering multiple employees must include a list of the employees covered by that expense. In no case shall an employee pay for the expenses of his/her supervisor," the proposed policy

The School Board sent the policy to a second reading without any proposed changes.

The Hudson School Board is set to meet again on May 20, at 6:30 p.m.

selection between enrolled students and non-enrolled district students must be made using the same criteria, such as registration registration deadlines. dates, audition/tryout, seniority by grade, etc. If, after applying such criteria the course/program remains overenrolled, the determination should be made randomly."

The proposed policy also outlines the procedure for the use of school texts and library materials.

"Non-enrolled district students will be permitted to use the school library, borrow school texts and borrow library materials under the same conditions and rules as pupils enrolled in the district," the proposed policy states.

The proposed policy also states that "In order to participate in district activities, non-enrolled district students must:

1. Meet the eligibility criteria for participation in the activity that apply to students enrolled in

the school district, with the exception of school attendance.

2. Meet any tryout crite-

ria or their equivalent for participation in the activity that apply to students enrolled in the school district (see School Board policy JJA); and

3. Comply with all policies, rules and regulations or their equivalent of the governing organization of the activity (see School proposed policy states. Board policy JJA)."

Editorial Preventing Lyme Disease

New Hampshire has an amazing quality of life outdoors with all four seasons, each one with different outdoor activities.

I love getting out of the house and getting some fresh air, however, my relationship with the outdoors has changed since having been diagnosed with Chronic Lyme Disease.

Since summer is around the corner and Lyme Disease Awareness Month is May, it's time for an annual refresh regarding ticks and Lyme disease.

Most people feel that you need to have a bull-eye rash to develop Lyme Disease, this isn't always the case. Typically, when a person first contracts Lyme Disease, they will develop flu-like symptoms about 7-21 days after the tick bite, with or without the rash. Lyme disease can spread to most organ systems including the heart and the central nervous system, hence the nickname "The Great Masquerader" since it could develop symptoms that mimic most any other disease.

Lyme disease can cause symptoms as serious as cardiac arrhythmias and even sudden cardiac arrest. It can cause neurological symptoms that often appear like Multiple Sclerosis or Parkinson's disease. Aside from the flulike symptoms, some other less obvious signs of Lyme include a buzzing or tingling sensation on the skin, a burning nerve pain, a great amount of joint pain, muscle pain, and incredible muscle stiffness.

Victims can experience a lot of

"brain fog", resulting in poor memory, difficulty with language skills, and in some cases even out right dementia. Though they are most prevalent in the summer, ticks can bite every month of the year.

There are a number of ways to prevent being bitten. Permethrin, a common synthetic insecticide, can be applied to clothing to make them tick resistant. DEET or Lemon Eucalyptus Oil can also be used as insect repellent for the skin. Wearing light and bright-colored clothing can help make it easier to spot ticks. Tucking the bottoms of pant legs into socks can prevent the ticks from climbing and hiding on legs. Clothes can also be put in a dryer for 10 minutes on high heat after coming in from outside to kill ticks.

If a tick becomes latched, remove it as soon as possible. The tick should then be placed in a sandwich bag with a small piece of damp paper towel with the date and name of the person who was bitten marked on the bag. It should then be brought to a doctor or sent to a lab to see if the tick was a carrier of Lyme disease or other infections.

Despite everything I still love to be outdoors, but now I usually do so in long pants sprayed with permathrin, and double up with a natural insect repellent for good measure. I also check for ticks even if I haven't been outside.

Enjoy the fresh air this season, but be sure take preventative measures from tick bites and seek prompt treatment if necessary. Stay safe!

School Board Review Special Education Evaluation Policy

The Hudson school Board had a first reading for a policy related to special education evaluations during its May 6 meeting.

Director of Special Services, Rachel Borge, said it's not a required policy, but it's "strongly recommended."

She explained that it's to make sure there is a policy for the evaluations they do in the District, or that they may pay for outside the District or for ones that parents bring to them to make sure "they hit a set standard so we're evaluating using quality evaluations," Borge said.

Borge explained that some school districts have received "less than stellar" information from the evaluations, which have led to problems.

The statement of policy states that "State and Federal special education laws require that the district, as the local educational agency ("LEA"), shall find, identify, and evaluate all children suspected to be children with disabilities. The District is committed to ensuring that each child's IEP (Individualized Education Program) team bases its decisions on high quality, reliable, and educationally sound special education evaluations."

timelines, and other procedures for requesting, initiating a referral, or conducting an educational evaluation relative to a determination of whether a child is a child with a disability, are as set forth in the NH Department of Education Special Education Procedural Safeguards Handbook, a current copy of which may be obtained from the child's building Special Education Coordinator, the District Student Services/Special Education office, or from the NH

office, or from the NH Department of Education. This policy establishes the criteria for those evaluations," the policy states.

As part of the evaluation criteria, it states that the

criteria, it states that the "evaluator must hold a valid license or certification from the state in which the practice is located, in the field related to the known or suspected disability. Said license or certificate must be consistent with the requirements set forth in the NH Standards for the Education of Children with Disabilities."

"The evaluator must have extensive training and experience in evaluation in the area(s) of concern and be able to interpret the instructional implications of evaluation results. In instances where no "applicable license or certification" exists, the district must be satisfied that the evaluator has extensive training and experience related to the known or suspected disability," the proposed policy states.

Borge explained that they wanted to allow families to go to neighboring states, noting that they often have families go to Boston for the evaluations and wanted to make sure they could continue doing so, which is the reason for not limiting it to just NH.

For cost and payment, it states that the cost "of the evaluation shall not exceed the usual and customary rate for such evaluations. The school district will not pay for the evaluation until it receives the evaluator's report."

The proposed policy also states that "The Director of Special Services or designee shall provide a copy of this policy to parents who indicate they are considering obtaining an IEE and shall make available upon parent/guardian request information about where an IEE may be obtained."

The School Board sent the proposed policy to a second reading without any proposed changes.

"I'm not convinced that everything is being done in a prudent fashion right now," said Cole.

Member, Randy Brownrigg, was curious about getting more information about Hudson's various reserve funds.

"Is it possible to get a copy of all of our capital reserve funds?" asked Brownrigg. "Can we see how much money is in each of the capital reserve funds, and can we also see in those capital reserve funds, what money has been taken out and gone to what place?"

The Chair stated he could provide that information should the request be put into writing.

"These capital reserve funds we have; do they earn any interest?" said Brownrigg.

He was informed that

all money Hudson has should be earning interest.

"I'm assuming it's the same way it used to be, but all the money that's in a reserve fund is in an interest-bearing account," said Jasper. "Not only that, all the money the town has at the end of the business day, it goes into a form where it's earning interest. All our money is always earning interest."

> A few issues were unfixable, such as the headstone for Frank B. Durgin, which was intact but seemed to have broken before being glued back together, leaving visible stains. Other, older gravestones were simply in need of cleaning.

Overall, despite a few issues, the Chair noted that Sunnyside was "looking not too bad," noting that DPW has been keeping up with many more serious maintenance concerns.

At Ford Cemetery, Christina thanked DPW for fixing the main gate.

"It's back up and it's beautiful, obviously repainted and put up with posts. That's amazing to

There were a few more downed branches at Ford, along with several broken heads and footstones to be placed on a "watchlist" for future repair.

Trustee, Maryellen Gannon, agreed to put metal "guide rails" on one headstone "before it snaps."

Blodget Cemetery needed a long-term solution to repair a stone wall along Pelham Road.

"In conversations last year with the DPW head, we discussed getting an estimate for professional repair to this very old wall," said Christina. "Hopefully, we have enough money."

They also removed several damaged flags in front of gravestones for military veterans. One heavily cracked headstone dated back to 1758, highlighting the age of the graveyard and town.

"These are some of the older ones," said Gannon, who promised to see if there was a way to clean and refurbish the eighteenthcentury monuments without further damage. "Simple Green and bleach, and stuff like that, all it's going to do is deteriorate the stone."

The Old Center Cemetery was in relatively good

condition, with some cleaning needed and a few headstones broken beyond repair. One headstone was damaged due to the use of improper cleaning products.

Senter Burial The Ground has a few headstones that need straightening. Several headstones had been knocked over and needed new rails. The stone fence around the perimeter also needed attention, part of it had been filled in by tombstones.

The Poor Farm gravesites had an issue with foliage growing over to block access to the gravesites during the summer months.

"A trim back would be a good thing," said Christina.

Apart from the trim and mowing the grass, Poor Farm did not need much maintenance.



School Board Approve Travel Request For SkillsUSA

The Hudson School Board was presented with a first reading for a policy related to school equipment during its May 6 meeting.

"No school equipment may be used for other than school, school-related, civic, or educational purposes," the proposed policy states.

The proposed policy explains that the Board "shall permit school equipment to be loaned to staff members when such use is related to their employment, and to students when the equipment is to be used in connection with their studies or extracurricular activities."

posed policy goes on to state that "It is the borrower's responsibility to return the equipment in the condition in which it was received, and the borrower's financial responsibility for any loss or damage."

"If District equipment is stolen while in the possession of the borrower, the borrower (and/or parent or guardian in the case of a student) must file a report with local authorities and file a claim with the borrower's insurance," the proposed policy reads. "The employee must also report the theft to their supervisor and the Business Administrator. The

In addition, the pro- student must also report the theft to the Principal or Assistant Principal."

> School Board Chair, Maureen Dionne, said that if the policy is ultimately approved by the School Board, then students and families of students who have district owned devices should be made aware of the policy, and that it should be included as part of the student handbook.

> "Let's keep in mind this policy should be included in the student handbooks," she said.

Benson Park Adds Another Trail for the Public to Use

looking to extend their hiking experience along the Haselton Farm Trail in Benson Park can detour and wander onto the Pelham Road Conservation area for a little extra time in the woods! According to Hudson's Conservation Commission Chairman Bill Collins, the Benson's Property and Pelham Road Conservation Area are indirectly connected by way of a twenty foot by two hundred forty foot easement along property owned by residents of Oak Ridge Estates. "The Pelham Road property was purchased by the commission in 2019 due in part to its close proximity to Benson Park," Collins said. After the purchase was commission members along with their

town liaison Elvis Dhima went to work procuring the Did you know? Folks easement that allows hikers to freely traverse between Benson's and Pelham Road. Collins went on to say that "one of the commission's goals is to purchase tracts of land that connect to great properties such as Benson Park expanding hiking opportunities to all those in the town".

In 2020, Ryan Clement of Boy Scout Troop 20 in Hudson sought and received approval from the Hudson Conservation Commission and Oak Ridge Estates HOA representatives to create a hiking and mountain biking trail along the easement that connects the two properties as part of his Eagle Scout project. Ryan's project included improvements to existing trail conditions, trail markings and creating an opening in the



stone wall running along the property boundaries.

Jennifer Cianciolo, a Friends of Benson Park volunteer, is an avid and experienced hiker. Jennifer discovered the trail while hiking the Haselton Farm Trail. She says that, "When you get to the Haselton Farm Trail point of highest elevation there is a marker identifying the Pelham Road Conservation Area

Trail. I recommend it for an enjoyable, quiet, scenic hike! I suggest hikers go out and back, which can be done in about an hour. There are many interconnecting trails, but for now I would stay on the main trail until additional trail markers are placed to help hikers navigate the intersecting trails."

The starting point that Jennifer uses is clearly

walk along the stone wall on your left until you come to a clean break in the wall where you will go left. Look for the tree with a left pointing arrow at that point. There are a couple of depressed areas in the stone wall before getting to the actual break in the wall, so don't be fooled. The actual break does not have any rocks on the ground between the two sides of the break and is also identified by the left pointing arrow. Look for the arrow mounted on a tree at the break in the

Jennifer says, "There are sufficient markers on trees to keep you on the path. Within about 30-40 minutes you will come to Pelham Road, where you can turn around and return to the starting point. (This turn-a-round point is across

identified. From that point, the street from 73 Pelham road.) This is a nice hike with interesting rolling terrain. My only caution would be that this is a low lying area, so avoid wet weather when planning your hike."

Bill Collins says that the Conservation Commission hopes to spend some time on the trail to evaluate placement of more trail markers. The Commission is proud of their acquisition of this land for Hudson's use and is pleased to have it as part of the Benson Park hiking system.

If you are looking for another enjoyable hiking path in Hudson, the Pelham Road Conservation Trail is definitely one to explore!

Senate Bill 442-FN, as amended: Bipartisan; AN ACT relative to student eligibility for education freedom accounts and the scholarship organization's costs of administering the program, extending phase-out grants for education freedom accounts, and revising the definitions of average daily membership in attendance and average daily

Senate Bill 330-FN, as amended: Moderately partisan; AN ACT relative to allowing the ability to work from home to count toward unemployment benefits eligibility. Hearing May 14 in the House Labor, Industrial, and Rehabilitative Services Committee

House Bill 1399: Slightly Partisan; Allowing municipalities to permit 2 residential units in certain single-family residential zones. Referred by Senate for interim study, scheduled for May 16.

House Bill 1596, as amended: Bipartisan; Requires political advertisements to disclose if they are using photoshop or AI to create fake media. The Senate Election Law and Municipal Affairs Committee voted

unanimously in favor of this bill. The Senate Judiciary Committee is also recommending the passage of other bills criminalizing harmful deepfakes, HB 1319 and HB 1432. Hearing May 15 in the Senate

House Bill 82: Partisan; Requires employers to make reasonable accommodations for legal marijuana patients. The Senate Commerce Committee voted 2-2 on whether or not to pass this bill. Hearing May 15 in the Senate.

House Bill 1312: Partisan; Requires school districts to notify parents two weeks before any curriculum related to sexual orientation, gender, gender identity, or gender expression. This bill also prohibits school districts from adopting policies that prohibit employees from notifying parents about students'

"mental, emotional, or physical health or well-being, sexuality, or a change in related services or monitoring." Hearing May 15 in the Senate

House Bill 1656: Bipartisan; Greatly increases the per-pupil state education funding for each student receiving special education services. The House

amended the bill to establish three weighted categories for special education differentiated aid, with more funding going to students who need more services. May 15 in the Senate
