Overlook Area May Soon See Many More Butterflies

The Londonderry Town Forest will soon have a large Butterfly Garden added to the area near the Overlook for the town to enjoy after the Town Council gave its blessing

on the project.

During the Monday night, June 15 meeting of the Londonderry Town Council, resident Martha Smith gave members a presentation on behalf of a number of groups plan to construct a butterfly garden near the

Overlook area of the Town Forest.

The land was originally donated to the town by Andy Mack Sr., who also attended the meeting that evening to show his support.

Couples Quest to Build Home on Class VI Road Slows Down

The couple who have been trying to find a way to build a home for their son on Brewster Road, a Class VI road, was put on hold during Monday night's Town Council meeting, as all involved search for a correct avenue to travel down.

Scott and Darlene Ratte, who own a parcel of land at 37 Brewster Road, have been to a number of boards in town over the past several months, trying to get the approval by the town to build a home for their son. The couple has met resistance, mainly because of state fire protection guidelines that were adopted by Londonderry in 2015. These guidelines prohibit homes to be

built on roads that fire apparatus cannot safely travel along, and the town's building department has told the Ratte's that they would have to reconstruct the road to bring it up to NFPA 1 Fire Code.

The Ratte's presented their plan to the Town Council on Monday night, June 15, after getting a favorable solution from the Planning Board earlier in the month. That board had recommended having the town reconstruct much of the road, up to a boat ramp for Scobie Pond, and have the Ratte's continue the reconstruction up to the new home.

Scott Ratte explained that they had bought the property before the town had adopted the NFPA standards, and now, be-

cause of these new codes, it has made their efforts unattainable.

Darlene added that the home would be for a young newly wed couple that wishes to stay in the town in which they both grew up, but without his permit they would most likely be forced to go elsewhere.

Councilor Joe Green questioned why they had purchased the property originally, and Scott explained that he originally bought it to keep from being bought by a developer. He added that when they bought it, it had an approved septic plan for the property.

Green stressed that in order for the town to approve building on the property, they need to

School Board Gets Updates for District Happenings

School board heard many updates from school district employees in all different areas in their meeting on June 2nd, 2020.

Among talks of class of 2020 celebrations the school board also heard from many other departments which gave updates as well. One of those updates coming from Kim Carpinone who is the Director of Pupil Services for the

school district on summer special education programming. Carpinone gave an update on ESY (Extended School Year) which is for students with IEPs (Individual Education Plans). ESY has been a topic of discussion since remote learning began because it is a requirement that all students with IEPs have services offered to them during the summer. A DHHS draft guidance is coming out for public guidance but can-

not be shared because it is still in draft form, but would convey a lot of information on how to go about having in person summer school held in the buildings.

Carpinone and rest of her team are taking guidance from the state and federal government for services for individualized student needs. Londonderry has decided that most of ESY would need to remain remote for safety reasons. There is a hybrid option with part of instruction being live remote and possibility of the other on one's own or in person instruction. There is about 200-225

students that require ESY in the district. The challenge Carpinone and team face is 'what is the best way to meet their IEP?' Carpinone and team called parents to ask them what the parents are willing to do and if they are comfortable with sending their kids into the school. They did this because for a Small percentage of those students tremote learning is not able to give them what they need. If they decided to do a portion of in person learning they would have lots of safeguards

and work with families to make sure they can follow those guidelines as well. Safeguards would include personal protective equipment for the staff, breaks in between services, having parents transport students, screening staff everyday for their temperature and asking them covid questions daily. Carpinone said they are in talks with parents to try and put something in place. The summer would also help make decisions on what the schools would need come fall time as

far as safety and instruction for students who need in person services. The board also heard from Buildings and Grounds Director, Chuck Zappola, regarding information on a recent power outage at the High School. The main underground electrical cable that provides electricity to three quarters of the building was lost. Phase 1 of the building is still powered and there is generator powering phase 2 which includes the cafeteria and kitchen, and Dining Services is still able to run

and deliver lunches to students. There are two portable generators to provide temporary power to the back of the building. Zappola has met with the representatives from Eversource, and the cable is the school's responsibility because of where it is located. The same cable failed 10 years ago and was repaired. This time there is one failure area and a couple other weaker areas. It would be cost effective to get a whole new cable because it is about 15 ft in the ground and would

require a lot of labor costs. The replacement was then greenlighted. The cost is about 62,174\$ and the contractors have already started and the project is looking to be done soon. Adjacent to this cable is an older cable and it was decided to replace that as well while the contractor and equipment is there. The cost for this cable is 27,000\$. Zappola did file a claim with insurance and they are optimistic that they will get back some of the cost from the incident.

tion Smith told the council that her, and a number of other residents had come up with the idea and had discussed it with the Conservation Commission, Beautify Londonderry, and Kent Allen, all of which were onboard with the idea.

Much of the garden will be done in two phases, consisting of two 45x125' areas. Their hope is to get community groups involved with the

plan, and allow it to expand as things develop.

A group of residents recently got together and discussed the possibility of creating a Butterfly Garden on a parcel of land currently owned by the Town, which was previously owned by the Mack farm.

The parcel is across the street from the Morrison House on Pillsbury Road, adjacent to the Kent Allen Forest and abuts a pumpkin patch on the Mack farmland and runs down to the ceme-

tery on Mammoth Road. The site runs about 45-feet from east to west and 250-feet from north to south.

Smith explained that the intent of the group is to create a colorful garden that will attract butterflies, along with other valuable pollinators plus a variety of birds to the area.

Marge Badois, Chairman of the Conservation Commission, Deb Curtin, a local artist and resident of Londonderry, Val Cloutier, also a resident, an avid gardener and member of the Derry Garden Group, Andy Mack, Sr., Smith and Councilor Deb Paul

recently met on the land and discussed how they envisioned the project.

Smith said that once the Town Council gave its approval the group will be reaching out to the community to garner interest in helping with the project.

Members of the group also spoken to Kent Allen, who also supported the project.

They will also be reaching out to the University of New Hampshire, The Audubon Society, local businesses and interested residents.

Smith told the board, "Our hope is that this spot, which is adjacent and very close to the

paths in the Kent Allen Forest, will be a place that residents of Londonderry can visit, enjoy and relax."

The idea is to have walkways through the garden that would allow visitors to walk through the garden and observe the flowers, plants, shrubs and hopefully butterflies and other helpful pollinators.

Andy Mack, Sr. has agreed to prepare the land for this use in the when the project is approved.

She added they plan to hopefully begin very soon, as there are good plantings that can go in for the coming fall season.

They will also maintain the land through

donations, and fund raising we will make this project self-funding.

Town Manager Kevin Smith told the council that he had met with Martha, and liked the idea, but asked that she get the approval of the Town Council. "Sounds like it would be a great project for the town," he said.

Ann Chiampa, the Curator of the Londonderry Historical Society's Morrison House Museum spoke in favor of the plan, and looks forward to seeing the flowers across from the museum.

Without much discussion form the council and with no objections, the plan will be moving forward.



Town Councilor's Temper Flares at Recent Virtual Meeting

An issue of normal procedures for Town Council members was brought up in the Town Council meeting that was held on June 2.

Council Member Tom Dolan had brought to light that fellow council member, Deb Paul, who attended a budget committee meeting expressed town council business at the meeting that had not been decided on as of yet. However, he adds that "I don't think she realized it at the time." Normally, the Town Council meets in a non-public forum to discuss strategies with a lawyer before going into

union negotiations. The issue Council Member Dolan brought up was when the negotiations came up at the budget meeting and she might have revealed part of the council's strategy.

Councilor Paul spoke next, stating, "I spoke as a resident and I made that very clear and I brought up two subject matters. One, I wanted to see their temperament on asking all departments in all Government; School, Library and Town to look at cutting the budget by 2-3 percent, and to look at it in advance and start a conversation with unions to look at something like not

accepting raises. I asked just to see what the temperament is to get things rolling so we don't get everything crammed down our throats."

Dolan then mentioned that "now that you're elected you're always speaking as a town council member. Asking to forego raise might be a violation of a labor law. When you ask them to forego raises it could cost some legal issues. Even if it's a good idea. Word to the wise just have to be careful to avoid litigation."

Chairman Farrell was next to enter the discussion reiterating that you cannot say you are a resident as an elected town

official. He also added that sharing things that come from Attorney-Client privilege nullifies the use of the strategy discussed in the email or meeting but did not think that Council Member Paul shared any privileged information.

Council Member Paul then spoke again "I have seen people say 'I am now speaking as a resident' in other meetings. If asking questions and trying to get a conversation started is wrong, I don't understand. I was trying to do what is best for the citizens of this town. I was throwing out an idea to make sure we had ample time to think about things

in lieu of COVID-19. I didn't want to rush it, I didn't mean any harm."

Then the meeting took a decidedly negative turn. Councilmen Jim Butler then emphatically reiterated the entire discussion and added that "you cannot have your cake and eat it too." It is also noted that Butler brought up that Paul had allegedly released privileged information when in prior discussion during the meeting it was decided that she did not.

After some back and forth between council members Butler and Paul,

Chairman Farrell explained that the way the statute is written you recues yourself as a voting member but not in general discussions. "Best thing you can do is ask the chairman to call a meeting with the town attorney to get best legal advice before speaking in another meeting." Farrell also added that "he does not expect you (Paul) to know everything" and understands it's a hard thing to understand.

After that additional explanation the meeting then moved on to the next agenda item.

make sure the Fire Department can get back there safely, and Scott mentioned that there are already six homes after the boat launch. "This wouldn't be the last house on that road," Ratte added.

Ratte also mentioned that in 2009, the town approved a plan to build a home that is three times the size of the home they are seeking to build and it sits on only one acre.

Town Planner Colleen Mailloux added to the conversation that the Planning Board recommendation came with a

caveat that the Fire Chief would have to approve a road width of 20-feet, and the NFPA standard is 24-feet. Mailloux also added that the town attorney has expressed greater liability if the road was widened only to 20-feet.

Mailloux also stated that even with the release of municipal liability signed by the residents the town still would have additional liability to be concerned with.

Council Chairman John Farrell brought up a number of past cases in town in which this situation has been run into, he also mentioned a recent case where residents had run out of water and they developed a warrant article to ask the voters for

their support in funding the project.

Chief Darren O'Brien sympathized with the Rattes, but said the state makes these codes for a reason, to allow the fire department to get to homes in a safe manner. His biggest apprehension was having to go out to that road during a snowstorm and meeting someone with a plow, and getting stuck.

O'Brien finished by saying that he could not in good conscience give his approval of making the road less than the 24-foot standard set up by the NFPA.

With that statement,

the Rattes were left to seek an alternative solution if they still wanted to pursue building on the property.

The council suggested a few routes they could take, one being an warrant article and another being an alternative route into the property, perhaps through an Ever-source Right-of-Way.

Farrell ended the discussion by saying, "Let us do a little bit more digging, unless you want us to make a decision tonight, and if you want a decision tonight, you know what the answer is. Unfortunately this is the world we live in today"

Summer Attractions Will Be Open, With Exceptions

As the official first day of summer approaches, New Hampshire residents might be wondering what summer break might look like for their families.

Previously, NH Governor Chris Sununu did not believe that state parks and other attractions would be open until late July. But in response to a decline in positive test results, the Governor felt optimistic. Sununu has stated

that the previously planned reopening date of June 29 for amusement parks, performing arts, and movie theaters still seems likely. Establishments and activities such as restaurants, gyms, and road races have been permitted to continue as of this week, each with their own restrictions in the interest of safety.

New Hampshire State Parks also remain cautiously optimistic about an all-things-considered successful summer, provided potential patrons observe a few now-familiar guidelines.

"The future status of parks and the availability of facilities will be determined by whether everyone is following all of the precautions," reads the NH State Parks update on the COVID-19 situation.

Beaches and State Parks have been open as of the beginning of this month, and have seen a significant amount of activity. The potential for residents to continue enjoying these attractions will depend on themselves and their fellow patrons.

Those planning on visiting a beach or state park this summer season should be prepared to adhere to the following safety measures:

Anyone experiencing symptoms of COVID-19 should remain home until otherwise informed by a doctor that they are cleared.

Visitors and family

groups should maintain a safe distance of at least six feet of one another.

Visitors should wear a cloth face covering over the mouth and nose to protect other visitors and staff when in locations where other consumers might be present, such as bathrooms, shops, and other closed-quarter facilities.

As of June 5, 2020, beach patrons have been permitted to sunbathe and partake in traditional beach activities, according to NH State Parks.

However, parking has been limited to a 50 percent capacity at Hampton beach, and sections of Oceanfront Blvd have been blocked off for pedestrian traffic only. Dropping off passengers or items in parking areas is not permitted at this time, and anyone found violating this rule will be subject to a fine.

Campers can look forward to taking part in their favorite summertime pastime, provided they plan ahead.

NH State Park has not been able to prepare campgrounds for the camping season this spring due to the pandemic. However, according to NH State Parks, the coming weeks will be

spent preparing campgrounds to open at 50 percent of normal capacity.

Residents should call ahead to reserve time to camp at operating campgrounds. State Parks currently accepting reservations are available at nhstateparks.org. The status of any existing reservations for summer 2020 can be checked by calling Reserve America at 1-877-647-2757.

As with beaches, all campers are expected to adhere to safety guidelines including remaining at home if exhibiting any flu-like or respiratory symptoms, keeping a distance of at least 6 feet between campers and family groups, and wearing a cloth face covering where other visitors may be present in closed quarters.

According to NH State Parks, reservations for pavilions and historic sites will be put on hold for the summer season.

Most playgrounds typically available at beaches, campgrounds, or state parks will also remain closed until further notice. However, the current status of individual parks will be available on specific

park informational web pages.

According to stateparks.org, much of hygiene safety will fall on park patrons.

"Remember that public places are only as clean as the last person who touched them," reads a passage regarding how often restrooms, showers, and other facilities will be cleaned this summer. The passage mentions that facilities are cleaned daily or more often, and staff will be keeping a careful eye on level of park use.

Patrons are highly encouraged to bring their own hand sanitizer, wipes, masks, and other sanitizing and hygiene products. Patrons are also encouraged to use credit or debit cards for transactions to reduce social contact.

As the situation with COVID-19 continues to develop, guidelines for state parks and other attractions may be subject to change. So long as patrons continue to do their due diligence, Granite-Statens can safely enjoy the season.



the above listed hours and tell the staff member that you would like to pick up an item. The staff will ask you information pertaining to the item(s) and format (book, DVDs, Books-on-CD, etc.) you wish to "check out". In addition, staff will be asking you for a time that is convenient to pick up the item. When you arrive at the library during your scheduled time, an employee will come to your car wearing personal protective equipment and they will look at your library card or driver's license through the driver's side window. Thereafter, you can "pop" open your trunk, and the employee will put your items (which will be bagged) into the trunk of your car. However, staff will not be collecting any returned items from patrons or their vehicles. If

you are returning items, please park your vehicle in the parking lot and then put the items in the book drop. By doing so, social distancing can be maintained and the pick-up line will not be impacted.
