Senior's Perspective On The Elderly Housing Ordinance

On Sept. 21, 2015 the Londonderry Town Council adopted Ordinance 2015-06 which became known as the Elderly Housing Ordinance. The Ordinance in part read: "Whereas the zoning ordinance shall permit opportunities for small work force housing developments, housing for older persons, assisted living, and elderly affordable housing that are more compatible with the character of Londonderry's existing residential neighborhoods;"

There are now 11 Londonderry and at least 2 more anticipated soon. Unfortunately, these senior developments would not be considered affordable to most seniors as the base costs without upgrades are comparable to or even exceed many of the single family type homes in town. Unfortunately, the developers of these senior communities were granted certain construction variances by the town common to high density type construction that allowed for stan-

dards below what is nor- lic road residents. It is mal for other types of housing projects. Primary among the benefits to the developers the town allowed variances in the construction of these private roads that did not meet the requirements of public roads. The construction of private roads meant that the town was not ever going to be responsible for maintenance, snowplowing, resurfacing, repairing, repaying, drainage, rental of fire hydrants or lighting for these communities as is done in other residential communities. Those are all significant costs "Over 55 Communities" in that are passed on to the unknowing senior residents. Although seniors moving into private road residences are told about the private roads it takes a few more years until they realize the ramifications. Since these senior communities assessed at values at or above other types of residences built on public roads our seniors are actually subsidizing the property taxes of everyone else while also paying separately for some of the services provided to pub-

obvious that seniors do not have school age children but are paying their fair share to educate the next generation because that is the price of living in a nice, quiet and safe town. Many of our seniors are coming from Massachusetts or another state where property values are much higher than New Hampshire so they can easily afford to live in town under these financial conditions but some unfortunate Londonderry residents are and will be forced to move elsewhere when it comes time to downsize. The developers have generated huge profits and move on while the town continues to receive significant tax revenues from these senior developments incurring little or no liability exposure or present or future costs since everything is paid for by senior residents who are generally on a fixed income.

It should be noted that there are many other types of private roads in Londonderry and throughout New Hampshire. Many in more rural areas date back 50 to 70 dirt roads, some are gravel and some are paved but most if not all require significant upgrades to meet municipal and state standards in order to become public roads. There has been at least one positive outcome from the elderly housing Sanborn ordinance. Crossing Apartments is an affordable complex in Northern Londonderry for those seniors 62 years of age and older who meet certain income criteria.

The town has stated that since New Hampshire is a Dillon Rule State as opposed to a Home Rule State the state must grant towns the authority to make property tax conto cessions resolve inequities which the Concord Legislature has not done. Apparently, municipalities in Home Rule States have authority to make some of their own regulations while in Dillon Rule States the state must grant specific authority to municipalities to deviate from state regulations.

There is a state-wide nonprofit organization called the New Hampshire Private Road Taxpayers Alliance (NHPVR-TA) that is pushing a bill to be filed sometime after the election to get legislation passed in Concord to form a committee to study the issues faced by all owners of property on private roads in NH and hopefully make recommendations to fix the inequities or discontinue the practice of approving

site is www.nhpvrta.com. This writer has been a part of the NHPVRTA since late 2019 when HB 1490 to study private roads and taxation passed the House of Representatives in March, 2020 only to be permanently tabled along with many other bills during the Covid-19 Pandemic.

er v Dover, which argued that variance requests can be made once rejected if material changes in circumstances can be demonstrated. March argued that by reducing the square footage of his request by 55% this would constitute significant circumstantial change.

March went on to comment about other signs in Londonderry and also brought up the Board's concern from August about the relationship between the linear length of a building and the allowed square footage of its corresponding sign. March commented that other towns in New Hampshire do not have the same requirements and that he be treated as other businesses in town such as Game Changer and Staples.

At this point Chairman Dunn interrupted March to poll the two other available board members, Feig and Benard, as they were the only two remaining members after member's O'Brien and Brunelle recused themselves from this case. Chairman

Dunn's opinion was that just by reducing the size of the sign constitutes a demonstrative or significant change thus allowing reconsideration for the variance. Feig expressed a contrary opinion that the size reduction did in fact make the request significantly different. The sentiment expressed by Feig pertaining to the 55% reduction was, in fact, substantially different and thus qualified. Benard also believed the information provided at the meeting on this night was previously unavailable or that certain information had

changed such that the Board or the applicant would not have been aware of at the time of the original application.

March then went on to cite another case in which the Zoning Board of Adjustment v. Town of Thornton, in which "subsequent application being modified to meaningfully resolve the Board's concern", alluding to the change in size, which was the Board's original concern.

Benard went on to state the previous argument was due to the large size of the build façade requiring a large sign should be allowed. At this point March made note of the fact he was not arguing the size of the façade, but more the actual length of the building. Benard stated that the Board had indeed inquired at the last meeting if the applicant would consider a reduction in the size of the sign. However, Mr. March did not attend the last ZBA meeting.

Chairman Dunn then suggested the board consult with the Town Attorney for guidance on the matter. March did ask for clarification if this guidance pertained to the

"meaningful change" referenced earlier in the article or just give guidance on the signage request. Feig then amended the request to the Town Attorney would answer the question as to meaningful change or to just provide guidance in this matter. Laura Gandia, the Associate Planner for the town, noted that Town Attorney the would provide guidance.

Benard then motioned to table the case until an answer from the Town Attorney could be obtained pertaining to both of the cases cited by March.

adding a number of parking spots. They are looking to give more breathing space to the workers at the facility and have added a large storm water runoff treatment area. They are also planning to add some landscaping around the new lot.

The Planning Department had a number of clarifications be made on the plans.

Without many questions from the board, and with nothing from the public, the board

approved the plan with the conditions that staff had recommended.

The next application was for a formal review of a subdivision plan of one lot into two at 5 Aviation Park Dr. R.J. Kelly Company, Inc. is the applicant and Burndy, LLC is the Owner. The plan is also associated with the next plan of an application for formal review of a site plan for the construction of a proposed one-story 40,521 square-foot trucking terminal and a proposed one-story 50,000 squarefoot warehouse building and associated site improvements.

Again, R.J. Kelly Company, Inc. is the applicant and Burndy, LLC is the Owner.

Earl Blachford, Shawn Smith and Steve Pernaw presented the plan once again since they had already presented the plan to the Planning Board at two other meetings.

Since the October meeting, Blachford said he addressed a number of concerns brought up, one of which was about traffic concerns and landscape and wetland concerns.

As far as traffic, Steve Pernaw addressed the traffic and said that the impact to the current intersection is at about 2.5 percent additional traffic.

Pernaw added that there is an existing need for a left turn pocket of about 1,000-feet on Harvey Road, but that the new development is only adding a minimal amount to that need.

David Debaie of Stantec spoke on behalf of the town and confirmed that there are problems with area intersections, both at Litchfield Rd., and on Harvey. He added that there are problems with the traffic counts to the current COVID-19 conditions, saying that they are currently off because of the fewer amount of cars traveling.

Pernaw then assured the board that the traffic studies taken for the plan were done before the Pandemic.

Debaie said he wasn't suggesting doing a new study, but to take into consideration what will be coming in the future.

The major concern was that there would be more truck traffic headed south on Harvey Road and end up on Litchfield Rd., which is a residential area.

Smith responded to the concern by say that 90% of the trucks would

be taking a right onto Harvey and away from the residential area.

The consensus on the traffic issue was that it was more of an enforcement issue for the town and not something the developer can deal with other than to require a right turn only sign for trucks. There were a number of conditions on the plan requested by the Planning Department and a number of waivers requested by the developer.

The two plans and waivers were approved unanimously by the board for the project to move forward.


