"I got up that day and emailed Mister Juster saying, 'I know it's last minute, but can I get in if you reschedule?' and he said 'Absolutely!' I was so excited for that snow day, for more than just a day off!" she said.

Cutuli said that seeing what her mother-inlaw went through while battling breast cancer made her see what a dif-

could make.

"It's amazing the amount of things cancer takes from people that don't think people about." said Cutuli.

Both of Sophmore Jilson, thanks to a lucky lian Mazzola's parents had gone through some form of cancer at one point, but are now thankfully cancer free. Still, Mazzola said that the desire to help others part of what was inspired her to donate for the first time.

"It's kind of like a rare opportunity to help someone who you won't ever know, but you'll know it is making a big impact." said Mazzola.

Dillon had initially planned for Londonderry Middle School student and Dillon family friend Lexi Adams to cut her hair, but due to the intensity of Adams's cancer treatment weakening her immune system, Dillon's boyfriend made the physical cut with Adams by her side via facetime.

Adams had first been diagnosed with cancer in the third grade. While she had overcome her first battle, tragically, the cancer would return a few years later.

"I watched her slowly lose her hair, and (saw) how she seemed more upset and self conscious," explained Dillon. "I decided I would donate in honor of her."

Though restrictions of the COVID-19 pandemic have lingered, Lancer Nation remains as determined as ever to keep up the tradition of having its Day of Giving take place on the gym floor, rather than to collect the hair separately.

Mazzola commented that the excitement of seeing her fellow students giving their hair was part of what helped motivate her to give her own, and without that others might not have that same motivation.

Lord echoed those sentiments, adding that holding the Day of Giving assembly gives the cause more recognition.

While giving up one's hair to give to those losing their own is a noble cause in and of itself, students agree that to experience the magic of giving alongside their peers leaves a much bigger impact, leading more to follow by example.

Editorial Prepare to Vote

Election Day in most towns in the state is March 8. In the days between now and then, we hope you'll listen to candidates speak, read their words, and ask them about the issues that concern

The March election has no state or national candidates, and that's traditionally bad news for voter turnout. We remind you, however, that your vote has far more impact on local government races than it ever will on the state or federal level.

Equally important are the warrant articles on both the town and school ballots whether it's the school budget or a request for a something, or funding for other things. Town and school requests should be handled the way you handle your checkbook can you afford it? Is it a necessity or a luxury? Is it something you can put off, or is that a false economy that will cost much more later on?

If you don't understand what you're being asked to approve, seek the answer. The right to vote is important, but it carries with it the responsibility of understanding the issues. It shouldn't sway your vote that the budget committee or your neighbor favors or dislikes a warrant article or candidate.

There are also Needs versus wants on many ballots. Choose wisely.

Candidates were asked why they're seeking office. Also warrant articles were reviewed, and have been written about for several weeks in this paper. Here are a few pointers: On a bond, pay attention to the financial obligation imposed for each year of the bond. The money will come out of your pocket for the life of the bond.

How about a union contract? If it covers just one year, its costs are likely to be clear. But most contracts are for two to five years. Make sure you understand the costs attached to each additional year you won't be asked to vote on it in future years, but the money will be added to the overall budget and will be part of your

Get the full picture. Because the choice is yours, and each article has pros and cons, and it pays to listen to both sides.

Many people like to pride themselves on their patriotism. There's not a much better way to express your patriotism than by heading to the polls and making informed choices.

So for your own good and the good of the community, please vote March 8.

Bring Positive Change to School District


To the editor,





- 3. Incorporate a pad-ready site with infrastructure and parking in place, saving the town substantial development and acquisition costs over other new facility options that were explored.
- 4. Relocate the School District Office back to the centrally located Municipal Office Complex, where it will neighbor the high school, middle schools, town government offices, and emergency response facilities.






