Town Council Warned of Possible Power Outages

During the Feb. 22 Town Council meeting the members heard from local State Rep. Douglas Thomas in regards to concerns about the power supply in New England.

He explained that he attended a webinar with ISO New England, which controls and manages the New England power grid.

“The reason why the webinar is important is because of a notice that ISO New England issued a short while ago, a notice that ISO New England has never issued before,” said Thomas.

He said that they may get to the point in the near future where there isn’t enough power

being generated in New England in order to keep up with the demand, especially during unusual cold snaps.

Dave Cloutier Director of System operations from Eversource explained that at first there would be a time period of heightened awareness where they make requests for people to conserve power usage.

“If that fails there will be an emergency declared,” said Cloutier.

He said that would hopefully hear from ISO several days in advance about a shortage of energy. He said that they would then have to turn off the number of customers that they tell them to. If it’s going to be a long period of time

they would rotate customers so it’s not a long block of time at once.

Cloutier said that they would prioritize the list so it makes sense including having hospitals at the bottom of the list.

Allison McLean from Eversource said that it’s important that the Town is preparing for it now and that they can help them with it. She also noted that unlike power outages during storms the police and fire departments would be included in the outage.

Thomas said that much of the reason for the problem in generating enough power to the grid comes from too little natural gas, which is necessary more in cold

Continued from page 1 receive the best possible education. While we should always strive for growth and improvement, I want to recognize that we have it really good here. Our students who go through our Londonderry schools go off to pursue wonderful things. This is a testament to our educators.

I have worked in schools for just short of fifteen years. I earned my M.Ed. while working my way through college as a paraprofessional. In my current role as an educational and behavioral consultant, I collaborate with parents, administrators, teachers, and paraprofessionals to help solve problems and effect positive change. This requires an understanding of everyone's priorities, use of evidence-based intervention and methods, and data to drive objective decision making. There is so much more to education than standardized testing. We need to meet kids where they are at. This multifaceted perspective is what makes me different.

In my experience, the foundation of working together toward a common goal is effective communication. This means listening to, and understanding, perspectives and facts before acting. This is what our community needs. Masking is

currently optional and I support this. Like everyone else, I hope that with a better understanding of Covid and a less severe variant, we can keep masks off. A petition to end masks, which ignores the federally and state recommended covid mitigation matrices designed by public health professionals, however, is shortsighted. It does not consider the perspective of medically fragile families, those who have lost loved ones to this virus, or the fact that our situation could change in the future. Our priorities as a district should be ensuring students and staff members are safe, while keeping our schools open for in-person learning.

Something I think we can all agree on is that we want the best experiences and opportunities for our kids. Mutual respect and common civility play an important role in accomplishing this and in moving forward together. When I spoke with educators in our schools, the impact that community discourse has on them was one of the common themes. It was mentioned that we can't even have our students and their teachers share their accomplishments at meetings anymore. We have a great opportunity to collaborate better, and model this behavior for our

kids so we can restore the culture of our town.

My professional experience, perspective, collaborative style, and ability to communicate are what we need to move forward, and what makes me the best candidate for this role.

Editorial

Be Prepared to Vote on March 8

Election Day for most towns in the state is March 8. In the days between now and then, we hope you'll listen to candidates speak, read their words, and ask them about the issues that concern you.

Local Elections results affect everybody in town; the money being sought after is your tax money, and you have the right to have a say in where it goes. This is your town, and your views make a difference, but only if you vote.

The March election has no state or national candidates, and that's traditionally bad news for voter turnout. We remind you, that your vote has far more impact in the local government elections than it ever will on the state or federal level.

In countries across much of the world people take to the streets and literally risk death to demand free elections and the right to have a say in their government. They look to the United States as an example of how government by the people works.

Equally important are the warrant articles on both the town and school ballots whether it's the school budget or a request for funding for other items. Town and school requests should be handled the way you handle your checkbook - Can you afford it? Is it a necessity or a luxury? Is it something you can put off, or will cost much more later on?

Staying home is easy, but taking the time to cast an informed vote is what a democratic country expects of its citizens. If you don't understand what you're being asked to approve, seek the answer. The right to vote is important, but it carries with it the responsibility of understanding the issues. Your vote shouldn't

be swayed by the vote of the town council or the budget committee. Your vote should also not be influenced the views of your neighbors. The vote is yours and you must vote on what is true to you, so choose wisely and educate yourself. In the local papers, there are bios of the candidates that run, sample ballots are printed, and the website of your town should have sample ballots posted.

We let ourselves and everyone else down when we ignore local elections. If you fail to vote and find yourselves taxed out of your home and represented by people who embarrass or upset you, complaining after the election will not help.

How about union contracts? Most contracts are for two to five years and add a dollar amount for each of those years it is in effect. Make sure you understand the costs attached to each additional year because you won't be asked to vote on it in future years; the money will be added to the overall budget each year and will be part of your future tax bill. When a warrant article states that there is no tax impact that may not be true for future years.

Please educate yourselves and understand the complete picture, the choice is yours. Each article has pros and cons. In addition, many have long-term implications that affect your wallet every year. It pays to listen and understand both sides' citizens and local governments.

Many people pride themselves on their patriotism. Theirs is no better way to express your patriotism than by heading to the polls and making informed choices.

So for your own good and the good of the community, please vote March 8.

To the editor,

Many thanks to the editor for giving me the opportunity to respond to some defamatory letters written about me. While I have previously chosen to ignore these constant attacks, I do feel that we've reached a point where failing to address this misinformation is potentially harmful to the culture of our community. I'm specifically responding to a letter to the editor written by Monica Plourde.

In the spirit of transparency, I have dedicated a Facebook post to my stance on each of the most pressing issues. If you look in the comments you will see that there are people who don't agree with me. The people who are banned are those who make false allegations or act in a blatantly disrespectful manner.

Monica referenced articles posted on my personal page. One was called, "Ten Things White People Can Do to Promote Racial Justice". I'm perplexed as to why, in 2022, this would be insulting to her. Does she not realize the alternative is racial injustice? Promoting acceptance is not CRT, and neither is advocating for the rights of individuals who identify as LGBTQ+. Everyone has a right to be accepted as they are.

My other post was a Newsweek article that looked at personality characteristics, like empathy, that best indicated willingness to wear a mask. I posted this in July 2020. Covid wasn't understood, the country was shut down, and hospitals were overwhelmed. I would argue that most of us were willing to wear a mask at this time, you know, for the greater good. Almost two years

later, masks are optional, but Monica continues to harass those with opposing viewpoints, because to her, different means bad.

What she conveniently omitted was that this past summer she was a part of a lawsuit suing the district for following federal and state mandates surrounding masking. How much taxpayer money went toward defending this lawsuit that could have instead gone towards TEACHING? Monica also left out that she feels that union teachers only care about themselves, that she called an esteemed principal "sick" following a presentation on social emotional learning, and that she publicly encouraged harassment of district administrators.

My critics very much want you to know that I didn't attend in-person meetings before my candidacy. I watched them from home. If, despite 15 years of experience as an educator, my watching virtually results in your selecting another candidate, I absolutely respect that and your right to vote.

Monica's letter, an attempt to hurt me, actually aids me, as it highlights the very behavior I have continued to speak out against. It is people who behave like her, not opposing viewpoints, that are hurting our community.

seven years. I believe that we have a beautiful, well-run town. While other candidates seek to bring radical change to our community, I seek to preserve both our fantastic school system and our exceptional public services.

In my early career, I served in the Army and as a police officer with the US Capitol Police. In an effort to move my family back to NE, I changed careers in 2015 and became a public school science teacher. while Salem High School took second with 190 and Nashua South was third with 126-points.

Pento had three wins and one loss at the MOCs. He started his day with a quick win by fall against a Merrimack opponent.

His second win was a close 6-5 decision over Cam Jordan of Conval High School in the quarterfinals.

In his semifinal bout, Pento had a 13-6 decision win over Caleb O'Rourke from Salem

Lancer Hockey Team Ends Season With OT Loss to Astros

The Lancer team tied the game with a goal by sophomore Mike Maloney with under a minute left in the game. The game-extending goal was assisted from junior Drew Cameron with the LHS goalie being pulled for a man advantage.

It didn't take Pinkerton long to score the game winner in overtime, despite a hard press from the Lancers to start the period.

The Astros celebrated the victory at 4:21 in OT when junior Lorenzo Corsetto scored an unassisted on a hard forecheck and Londonderry turnover.

The Lancers were given a bye in the first round of the NHIAA playoffs and will start the tournament, on Saturday, March 5, with a trip to Hanover to play the Marauders at Champion Rink in West Lebanon starting at 3:20 p.m.

The Hanover High School squad finished the season at 12-5-1 and gained the number four seed in the tournament. Londonderry suffered a close 4-3 loss at home to the Marauders in their only meeting this season.

The Proposed Conservation Land Swap

To the editor,
Article 17 on this year's Town ballot asks voters to release a conservation restriction on 23 acres of former orchard at 35 Gilcreast Rd., for no less than \$2,650,000. Article 18 appropriates \$750,000 of this amount to replace this

land with separate conservation land of equal or greater conservation value. The remaining \$1.9 million will become fund balance, which historically has been used either to lower the tax rate directly, or to support taxpayers in other ways. The articles are contingent upon each other, meaning that if one fails, the other automatically fails.

The Town purchased the conservation restriction in 2003 for \$1.23 million to reduce the scope of a proposed 361-unit development on the orchard parcel as well as on the abutting parcel, which is now the Nevins Retirement Community. The Nevins is separated from the former orchard by undeveloped, forested land extending at least 600 feet east toward the former orchard. This land is owned by the Nevins homeowners, is legally protected, and will not be affected should these articles pass.

Today, the former orchard is thickly overgrown. The conservation restriction prohibits public access. The soil is contaminated with chemicals associated with the historical application of pesticides. While the parcel has some value as wildlife habitat, it is too small and isolated from other natural areas to host a robust natural community.

We must consider whether this will create a "precedent," and jeopardize

other conservation easements in Town. Unlike most conservation restrictions, this restriction allows it to be amended or revoked by the voters. The Town's easements on Moose Hill Orchards and Sunnycrest Farms, for example, do not. The Town has every intention to continue to protect the conservation properties we all cherish.

Any proposed development must comply with the Town's zoning ordinance and other regulations. Additionally, because the Town holds the conservation restriction and can always decline to release it (even after the passage of these articles), the Town has even more control than it normally would. The Town has informed the developer it will not permit apartments.

Should Articles 17 and 18 pass, the Town Council and the Conservation Commission will be authorized, but not required, to move forward. Before giving final approval, both bodies must be satisfied that the transaction makes sense for the Town. They will consider two criteria: 1) The transaction must produce equal or greater conservation value, and 2) The development of the former orchard must benefit Londonderry.

Voters will decide whether this makes sense for the Town. We are not advocating for a particular

result. We have tried to explain the articles, their effects if passed, and to dispel any misunderstandings that may exist. In closing, it is up to you, the voters, to determine if Articles 17 and 18 make sense for the Town. We can think of no better way to decide this complex question.

neighbor issue?

speeding complaints is a tiny fraction but the Traffic Safety Committee as well as the Londonderry P.D. respond to complaints. Well, this is an opportunity for all the rest of us who have no complaint and who oppose a Town-wide speed limit to be heard and counted. Let's nip this emotion-driven idea in the bud. winter month. He added that the pipelines aren't big enough to supply power plants.

One question that was asked was if the outages would only happen during cold weather.

Cloutier said that it can happen any day of the year depending on how much power is generated in New England. He said that they are more concerned during the winter because home heating uses a lot of natural gas.

Town Councilor Tom Dolan asked about people with generators and was told that it would be like any other outage

that happened.

"For the customer it's going to be like any standard outage," said Cloutier.

Town Council Chair- man John Farrell said he was concerned especially if hospitals aren't able to have power.

"Godforbid you take a hospital offline," said Farrell.

Town Councilor Deb Paul asked how Ever- source and other compa- nies would be correcting the situation and how they are going to make it up to the people affected by the power outages.

"How are you guys going to compensate for your poor vision to the resident, and the commu- nity and municipalities and the hospitals, for your

inability to foresee what was going to happen con- sidering your rates go up considerably," said Paul.

In regard to correcting the issue, Thomas said that some efforts were made to correct things but residents shot down the North Pass project and the gas line expansion project.

Farrell said that the State needs to come up with a solution to the problem.

"Someone in Con- cord needs to get their act together and figure out what we're going to do next," said Farrell.

Farrell closed by say- ing that he wasn't happy with what they are facing.

"How ridiculous is it that we're sitting here having this conversa- tion," said Farrell.
