## Police Department Looks to Improve Retention of Officers

Deputy Chief of Police, Kim Bernard, expressed several goals for the Londonderry Police Department in 2022. Bernard pledged that the Police Department would “continue being finan-

cially responsible to the budget” of Londonderry.

One issue raised by Bernard was the cost of maintenance. Costs include yearly maintenance on boilers, heating, and cooling systems. The duct system has not been cleaned since the current depart-

ment moved into their building. It will require \$30,000 to properly clean the ducts, well above the \$18,700 budget the department current has for the expense.

Vehicle maintenance is another ongoing expense. Bernard found

## Concerns Raised Over Elderly Taxes at Town Council Meeting

During the April 11 Town Council meeting, members and the public expressed concern over the taxes paid by older residents. There are concerns that the current tax brackets have not been adjusted for inflation.

Councilor Joe Green has expressed a desire to reform exception caps for the elderly. Under the current system, an unmarried elderly resident of Londonderry making up to \$40,800 has an exemption with the rate at

\$50,300 for married couples. Green proposed a discussion on how to raise these limits without a negative impact on the town budget. He further stated that “as prices continue to increase past Covid, these numbers are a little bit low.”

Another suggested reform was in reexamining a law regarding members of the elderly community with a deceased spouse. Under current rules, only a living married couple falls under the higher exemption rate. A widowed individual receiving two pensions is con-

sidered single, with the \$40,800 exception cap.

In public comments, resident Joan Chmielorz spoke at length about the personal impact of the current tax burden. Chmielorz described giving “every cent” of her federal tax refund back to town in July.

She also described needing to borrow \$375 from her grandson. “I am begging you because I think I’m going to have and sell my house and leave, I am begging you, to think about the poor people...this is killing me.”

## Groundwater Protection Ordinance Sent To Council

During the April 13 Planning Board meeting, the Board held a public hearing for a proposed zoning ordinance amendment that would add a Groundwater Protection District.

“The purpose of this ordinance is, in the interest of public health, safety and general welfare, to preserve, maintain and protect from contamination existing and potential groundwater supply areas and to protect surface waters that are fed by groundwater,” the proposed ordinance reads.

The proposed ordinance lays out what the prohibited uses are in the Groundwater Protection District:

A. The development or operation of a solid waste landfill;

B. The outdoor storage of road salt or other deicing chemicals in bulk;

C. The development or operation of a junkyard;

D. The development or operation of a snow dump;

E. The development or operation of a wastewater or septage lagoon;

F. The development or operation of a petroleum

bulk plant or terminal;

G. The development or operation of gasoline stations.

The proposed zoning ordinance amendment also explains what the regulations are for existing non-conforming uses.

“Existing non-conforming uses may continue without expanding

# Conservation Commission Discusses Plans for Landscaper Plan

The Conservation Commission discussed a site plan submitted by Outdoor Pride Landscaping LLC at their Tuesday, April 12 meeting.

Robert Duval of TF Moran attended the meeting on behalf of his client. "The site is about 2.6 acres, and it is a site plan for a landscape contractor who has a warehouse and repair building where he takes care of his landscape trucks," said Mr. Duval. "There is an outdoor storage area on gravel to the right, a paved circu-

lating area in front of their building and then a gate. Outside the gate, there are about 15 or so parking spaces and a driveway on to Kitty Hawk Landing."

Duval gave the layout of the site plan for Outdoor Pride, but the Commission was unclear of the history behind the site, so he was asked to clear that up. "The most recent buyer of this lot was S.W. Cole. They were planning to build their office building on this site, but they have decided to make other plans and put it back on the market," said Mr. Duval. "This buyer, Outdoor Pride, now holds a

PNS on the property and is looking to develop it."

Outdoor Pride Landscaping bought the property from S.W. Cole so they can expand their operation into Londonderry.

Duval also explained that there is a leveled pad area by the parking lot that was put there by the people who owned the property before S.W. Cole. Outdoor Pride wishes to readjust that pad area so it can conform to Londonderry's regulations regarding drainage and open space.

After going over the on-site details, Mr. Duval transitioned into discussing the off-site details

of the plan concerning the six lots that surround Outdoor Pride's newly acquired land.

He said, "These six lots off-site were originally designed back in 2002 to drain to a common tension pond that is just across the street from [Outdoor Pride's] site...That lot [across the street] really has little on it but there is an easement on that property that favors the other six lots. They were all given an allocation of stone water run off at the time."

He continued to explain that S.W. Cole had an approved plan to build a facility on the lot

now owned by Outdoor Pride. It was discovered at the time of the approval that the pond needed some maintenance work as it shrunk, and it needed to be restored to its original size.

"It was agreed by S.W. Cole that they would do that [maintenance] work," said Duval. "The new buyer is sort of inheriting this requirement to do this work." S.W. Cole had all the plans approved but never did anything with the site.

Duval explained that they sat on it for four years before putting it on the market which is

when Outdoor Pride came in and bought the property. The maintenance work on the pond is the only thing that Duval claims needs to be worked on in terms of conservation.

The Conservation Commission had plenty of feedback to give and Duval agreed to adjust the site plan with the feedback added in and will present the new adjusted plan at a later meeting for the board's approval.

The Commission's next meeting will be on Tuesday, April 26 in the Moose Hill Council Chambers at 7 p.m.

# Planning Board Sends Poultry Ordinance to Town Council

The Londonderry Planning Board held a public hearing on a proposed zoning ordinance amendment related to poultry on April 13.

Planning Board Chair Arthur Rugg said a lot of research was done on the topic.

"Our staff has done quite a bit of research on it," said Rugg.

Londonderry Town Planner Colleen Mailloux said she learned about it while they worked to draft the proposed ordinance.

"I learned a lot about chickens," said Mailloux.

Under the proposed ordinance lots between one and two acres will be allowed to have no more than 12 poultry, other than turkeys. They will be allowed to have no more than six turkeys.

For lots between .5 and one acre they can have no more than six poultry and no turkeys.

No poultry will be allowed on lots smaller than .5 acres.

The proposed zoning amendment also states that no roosters, geese or guinea fowl will be allowed.

Other regulations for lots smaller than two acres includes having the poultry property enclosed at all times.

"Enclosures must be roofed (wire or mesh roofing is acceptable) and shall be adequate to prevent the poultry from escaping from and trespassing on public or private property," the proposed ordinance reads.

Other language states that "a minimum of three square feet of sheltered coop and 10 square feet of enclosed outdoor run shall be provided per bird, with the exception of turkeys

which require a minimum of 6 square feet of sheltered coop and 10 square feet of enclosed outdoor run per bird."

The enclosures will need to be at least 25 feet from any property line as part of the proposed zoning amendment.

Mailloux said the proposed ordinance wouldn't change anything for lots that are two acres or larger.

Planning Board member Jake Butler said he thinks the proposed zoning amendment has made progress since it was first being drafted.

"I think it's pretty

good. It's come a long way since it first started," said Butler.

He said he thinks it's reasonable what they are proposing.

Planning Board member Roger Fillio also thought it was good.

"I'm happy this is a good start, you have to start some place," said Fillio.

Ex-Officio Deb Paul said she is happy that they are going to allow property owners with less than two acres the opportunity to have chickens.

"I'm happy that this is in place," said Paul.

Paul noted that she

has already gotten many calls from people who are excited that they may be able to get chickens for their property now.

The Planning Board ultimately voted to send the proposed ordinance to the Town Council for their consideration.

Rugg said that the Town Council will have two readings on it with one being a public hearing. The first reading he said would be to introduce it and then the second reading would be a public hearing.

The Public Hearing will be on May 23 at the Town Council meeting.

or changing to another non-conforming use, but must be in compliance with all applicable state and federal requirements," the proposed ordinance reads.

Some uses are exempt from the provisions of the proposed ordinance as long as they are in compliance with all applicable local, state, and federal requirements. They include:

A. Any parcel located within the Airport District is exempt from this Groundwater Protection Ordinance;

B. Any private residence is exempt from all Performance Standards;

C. Any business or facility where regulated substances are stored in containers with a capacity of less than five gallons is exempt from Sec-

tion 4.6.8.11, Performance Standards, sections E through H;

D. Storage of heating fuels for on-site use or fuels for emergency electric generation, provided that storage tanks are indoors on a concrete floor or have corrosion control, leak detection, and secondary containment in place, is exempt from Performance Standard E;

E. Storage of motor fuel in tanks attached to vehicles and fitted with permanent fuel lines to enable the fuel to be used by that vehicle is exempt from Performance Standards E through H;

F. Storage and use of office supplies is exempt from Performance Standards E through H;

G. Temporary storage of construction materials on a site where

they are to be used is exempt from Performance Standards E through H if incorporated within the site development project within six months of their deposit on the site;

H. The sale, transportation, and use of pesticides as defined in RSA 430:29 XXVI are exempt from all provisions of this ordinance;

I. Household hazardous waste collection projects regulated under NH Code of Administrative Rules Env-Hw 401.03 (b)(1) and 501.01(b) are exempt from Performance Standards E through H;

J. Underground storage tank systems and aboveground storage tank systems that are in compliance with applicable state rules are exempt from inspections under Section 4.6.8.14 of this ordinance.

Planning Board Chairman Arthur Rugg said that they had spent a considerable amount of time on it, and said that they modeled it based on the state model for groundwater protection.

Londonderry Town Planner Colleen Mailloux said that they recognize that they are going to make updates based on new watershed protection areas being developed in town and as some are taken away in the future.

"It's an administrative obligation that will be the responsibility of the GIS manager," said

Mailloux.

Planning Board member Ann Chiampa said that she is glad they are going to have it in town.

"I'm glad to see this coming," said Chiampa.

Ex-Officio Deb Paul said that she thinks they need to check on the updates to the watershed areas frequently.

"We need to keep checking this on a regular basis," said Paul.

Paul said that having the data being as accurate as possible is really important.

"We have to really keep track of this moving forward," said Paul.

Mailloux said that they are going to be looking for feedback from other communities that have similar ordinances to see how often they update them.

Planning Board member Roger Fillio said that he thinks it's a step in the right direction.

"It's a good first step," said Fillio.

The Planning Board ultimately voted unanimously to send the proposed zoning amendment to the Town Council for their review. The Public Hearing will be at the May 23 Town Council meeting.

Councilor John Farrell explained a few possible difficulties with tax reform. He noted that "23% of [the budget] runs the town, and 75% of it runs the school." State law prevents the Council from pulling any money out of the school system, limiting possible options.

One suggestion was asking the School Board to look into education funding. Despite having fewer students, funding levels have remained the same. Maintaining the financial safety of Londonderry is a central goal.

Any new tax exemptions would need to come out from the smaller, town side of the budget. Existing concerns include maintenance for public buildings and more funding for public safety employees. Londonderry is also below goals to rebuild the undesignated town budget. The alternative to make

Despite concerns over where to find the money, the Council has pledged to discuss possible solutions for tax reform. Unexpected revenue from the federal government and unspent budget money provides some possible solutions to the issue.

Green proposed changes "without any

tax impact" using unexpected revenue sources and leftover money from other projects. He asked Finance & Administration if it is possible to use "tight analysis" and "to pass on tax rates and elderly exceptions to people who need them." Acting City Manager Michael Malaguti advised that tax credits are possible with the current budget surplus, though not necessarily a good idea.

The discussion remains open on when and how to change the law without impacting the budget. Tax reform will be revisited in the next public hearing.

# Planning Board Discuss Tree Cutting On Adams Road

During the April 13 Londonderry Planning Board meeting the Board had a public hearing for the removal and trimming of trees by the Londonderry Department of Public Works along Adams Road.

Planning Board Chairman Arthur Rugg said that if the road is deemed as a scenic road the Planning Board has to have a hearing on it for any changes.

Londonderry Town Planner Colleen Mailloux said it's an opportunity for the public to understand that they are cutting down some of the trees and the reason for it. She said that the ones that they have identified are hazards.

"There's some sort of

intimate danger there," said Mailloux.

Director of Engineering and Environmental Services John Trottier said that 11 trees have been marked.

Trottier said that the last time they did a big tree removal was about 20 years ago when they cut down 40 trees. He said that when they cut down the trees they will also look at what needs to be trimmed, and will do so.

Planning Board member Ann Chiampa said that she is concerned that the road is becoming less scenic.

"That scenic road is becoming less scenic," said Chiampa.

Chiampa said that trees make up part of the scenic view particularly during the fall.

"They are part of that view especially in the

fall," said Chiampa.

She also argued that they need to do something as a Town to keep it scenic.

"We should do our part keeping it scenic," said Chiampa.

Rugg said that they can look into it.

"We will have to look at what we can do for replacement of trees," said Rugg.

Ex-Officio Deb Paul agreed that the trees do make a road attractive but she also said that this is a safety issue and maybe the property owners would be willing to plant new trees if they get taken down on private property.

"It's not the town's property, it's the land owner's responsibility," said Paul.

One question that was asked was what the

projected timeline would be for the tree removal.

Trottier said that it would likely take a couple days and it would be done within a month.

He said that they would keep one lane of traffic open the whole time it is being done.

Planning Board member Jeff Penta asked

where the wood goes when it is cut down.

"Typically it goes back to the yard," said Trottier.

Planning Board member Lynn Wiles said that he agreed with the staff's assessment.

"I agree with your assessment," said Wiles.

Wiles said he thinks

that it would be a good idea if they can buy 11 trees and plant them somewhere else in town.

Planning Board member Roger Roger Fillio said he agreed about planting new trees in town but said that they should talk to the Conservation Commission if they are going to do so.

# Department of Environmental Services and St-Gobain Performance

The NH Department of Environmental Services (NHDES), represented by the Office of the Attorney General, and Saint-Gobain Performance Plastics (SGPP) announced Monday they have reached an agreement to permanently provide safe drinking water to approximately 1,000 properties located in portions of the towns of Bedford, Hudson, Litchfield, Londonderry, and Merrimack. The agreement also provides a framework for moving forward on additional properties that may be impacted by SGPP.

"We are pleased that the State and Saint-Gobain were able to reach agreement to provide safe, alternate water to approximately 1,000 properties in this five-town area, where private drinking water wells have tested above the State standards for PFOA. The families and businesses occupying these properties will finally get a permanent solution, after a long period of relying on bottled water," said Bob Scott, NHDES Commissioner. Attorney General John Formella added "Ensuring safe drinking water is something we take very seriously. This agreement is an important step forward in a continuing, multi-faceted effort to ensure impacted NH residents have access to clean drinking water."

Following the initial discovery of perfluorooctanoic acid (PFOA) in area drinking water in 2016, which NHDES attributed to air emissions from the SGPP plant in Merrimack, NHDES launched a massive testing effort to determine the extent of the contamination and conducted emergency rulemaking to establish a groundwater quality standard for PFOA

of 70 parts per trillion. SGPP and NHDES worked cooperatively to quickly address those properties at greatest risk, providing interim bottled water to impacted residents, and point-of-use treatment systems (POET) or water-line connections to over 500 properties, primarily in Litchfield and Merrimack. In 2018, the State and SGPP entered into a Consent Decree (CD) memorializing responsibilities with respect to the work already completed, providing water-line connections to an additional 302 properties, and setting the groundwork for future remediation efforts.

In September 2019, NHDES lowered the state drinking water maximum contaminant level (MCL) to 12 parts per trillion for PFOA and directed SGPP to commence an extensive well sampling program. At present, approximately 1,000 additional properties have tested above the new standard and have been offered bottled water by SGPP. Pursuant to the agreement, a total of 353 specific properties have been identified to receive either a waterline connection or a POET. Further, SGPP must propose an alternate water solution for the more than 600 remaining properties that have been offered bottled water. In addition, as sampling is completed, SGPP will propose solutions for newly identified wells testing over standards.

This agreement will provide waterline connections or a POET for 353 specific properties including:

- Bedford, south of County Road and east of Liberty Hill Road:

- Water line connections to 15 properties

- Point-of-entry treatment (POET) systems for 181 properties

- Litchfield, Hillcrest Road Area:

- Water line connections to 77 properties

- Merrimack, Wildcat Falls Area and Brenda Lane:

- Water line connections to 32 properties

- Other Areas in Bedford, Merrimack, Litchfield, and Londonderry:

- Water line connections to 48 properties

Under the agreement, SGPP must make all reasonable efforts to ensure that design work is initiated within 30 days and that applications for regulatory approvals are completed or obtained by June 30, 2022. Simpler connections to existing water lines are anticipated to begin this summer, with more complex water line extensions being constructed in 2023. POET installations are anticipated to begin this summer following submittal of a POET workplan by SGPP and approval by

NHDES. In the coming weeks, owners of properties that have been specifically identified in the agreement should expect to receive additional information. However, if property owners have questions, they are encouraged to call SGPP at 1 (800) 742-8498.

The agreement is available here: NHDES and Saint-Gobain Performance Plastics Alternate Water Agreement, April 2022.

Pursuant to the agreement, the State did not waive any private right of action by any individuals or parties.

NHDES will host a remote meeting for all affected communities Wednesday, May 4, at 6:30 p.m. to discuss the specifics of the agreement, the steps that will follow, and to answer questions.

that the department is “budgeted for \$4,000, we’ve been at \$4,000 since 2012. We’re well over that every year.” Oil changes alone for police vehicles average at \$5,000 every year.

Recruiting and retention is another chronic, ongoing issue not unique to Londonderry. If an applicant passes a strict background process, it takes one year for them to go through local training and the police academy in Concord.

Open Enrollment is one solution to the staffing problem. Throughout the year, the Services Bureau will advertise that Londonderry is taking open enrollment. The program solicits certified officers throughout NH, skipping the training process, though it still takes time to find new officers.

Bernard found that attrition is an ongoing problem. He said that “two months ago we lost an officer to retirement, we have another retiring at the end of this month, we have another retiring in July.” He noted that “there’s not many jobs out there where you have to say goodbye to your wife and kids or your husband” to work late nights and early morning. At the height of COVID, short-staffing meant some officers were getting called out up to three times per week. All three retirements are early retirement, and that police attrition is a nationwide problem, not one restricted to Londonderry.

Officer salary was cited as a secondary problem in combination with difficult working hours. Londonderry has historically had a comparatively high salary next to other departments in the state. However,

it still does not compare to the pay of jobs in the private sector.

Acting Town Manager Mike Malaguti reiterated that the staffing shortage is “not just a Londonderry concern, it’s something that people are thinking about at the state level and local communities, probably every local community around the state.” Assistant Manager Lisa Drabik has experience studying the recruitment issue. She cited anecdotal evidence that the recruitment problem is particularly generational. Younger recruits are more concerned with quality-of-life issues, a concern the department can take into account.

A final note was the necessity of having a plan to increase recruitment. Creative solutions have often been as simple as putting up recruitment posters in local gyms.
