## Three Individuals Charged in Connection to Toddler's Death

After several months of ongoing investigation, three individuals were arrested last week in connection to the death of an infant at the RMK Truck Stop near Exit 5 on

Rockingham Road in Londonderry.

According to a report released on Wednesday, Feb. 24, officers responded to the RMZ Truck Stop at 137 Rockingham Road on at 9:42 a.m. on Monday, Nov. 16, 2020, after a report of an uncon-

scious and unresponsive two-year-old female located inside a vehicle in the rear parking lot of that facility. A day-shift patrol sergeant was nearby and arrived on scene within one minute and began performing CPR on the

### Sara Loughlin

Q: Why did you choose this town position to run for?

## Town Council Names Nine People to Water Task Force

After a long discussion during its previous meeting the Londonderry Town Council regarding the PFAS Task Force, the council came to a decision of who will be on the task force.

After major issues regarding the amount of PFAS-related contamination in the town's drinking water was realized by the town and the community it was decided that a task force would be created to help tackle the problem.

Before it was decided

by the council who would be appointed to the task force one decision that they had to make was how many people would be on it.

Steaming from discussion at the last council meeting the council voted on a resolution to add three alternative members to the task force.

The council approved the resolution meaning that there will be a total of nine members on the task force with six being regular members and three alternatives.

Being appointed to the task force was Jim Doucakis, Craig Durrett,

Anne Fenn, Thomas Gar-side, George Kadziola and Paul Lockwood.

Alternatives to the task force will include Brian Lockhart, Kate MacDonald, and David Robinson.

While only nine out of the twenty people who applied were pick-

Below, we gave each candidate a chance to share with residents why they are the best choice for voters.

The election will take place in the Londonderry High Gymnasium on Tuesday, March 9, from 6 a.m. to 8 p.m.

## Jim Butler Incumbent

Q: Why did you chose this town position to run for?

A: I am running for re-election to the town council to continue my efforts to maintain a fiscally responsible town budget. # Senate Bill Seeks Fairness for Residents on Private Roads

Senator Sharon Carson, Londonderry, District 14 has filed SB-131-FN, Part IX requesting fair and equitable property tax treatment for residents who live on many types of private roads throughout New Hampshire. The bill is co-sponsored by Representative Max Abramson, Seabrook.

SB-131-FN, Part IX authorizes municipalities to provide qualified private road communities the same services given to public road residents such as snowplowing, road repair, road replacement and maintenance of certain infrastructure items such as municipal water and sewer. In lieu of providing those services municipalities would

also have the option to offer individual private road homeowners a property tax credit representing the municipalities estimated costs of providing those services.

This legislation is aimed at treating private road residents the same as public road residents since property valuations and assessment are computed

exactly the same for properties on both types of roads. These private road communities are a financial boom to the municipalities who approve them and the developers who build them since roads and corresponding infrastructure do not usually meet established standards and regulations. Therefore the costs are less to

construct these projects and neither the municipalities nor the developers ever have any financial or legal obligations after complete occupancy. Although the purchasers of private road properties are advised of the private road situation the full impact of their obligations and costs are not apparent until 3-5 years later when they

are confronted with setting aside enormous capital reserves for anticipated costs.

child until Londonderry Fire Department paramedics arrived.

The approximately one-year-nine-month-old female was taken to Parkland Medical Center where she was pronounced deceased.

An autopsy was later performed on the child by the New Hampshire Office of the Medical Examiner, and the cause of death was determined to be by an acute fentanyl intoxication.

Following the autopsy, the Londonderry Police Department Detective Unit, in consultation with the Rockingham County Attorney's Office, applied for and was granted arrest warrants for the following individuals for the following alleged offenses: Mark Geremia, 32, of Northfield, N.H., the

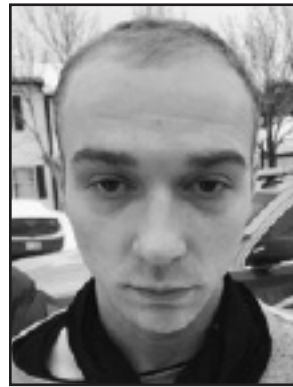
infants father, was charged with a Class-B Felony charge of Negligent Homicide; Manslaughter; Reckless Conduct with a Deadly Weapon; Falsifying Physical Evidence; Receiving Stolen Property; Conspiracy to Commit Falsifying Physical Evidence; three counts of Possessing Child Sex Abuse Images; and Two Class-A Misdemeanor charges of Endangering the Welfare of a Child.

Shawna Cote, 29, of Tilton, NH, was charged

with: Negligent Homicide; Manslaughter; Reckless Conduct with a Deadly Weapon; Falsifying Physical Evidence; Two charges of Endangering the Welfare of a Child; Receiving Stolen Property; and Conspiracy to Commit Falsifying Physical Evidence.

Londonderry Police Detectives were assisted by members of the Drug Enforcement Agency Manchester Field Office and NH Internet Crimes Against Children Task Force in their investigation and by the United States Marshall's Office Dis-

trict of N.H. Field Office in the apprehension of the suspects, who were located at an address in Northfield, NH on Feb. 23, 2021.

Both Geremia and Cote were held on \$10,000 cash bail and transported to the Rockingham County House of Corrections pending arraignment on Feb. 24, 2021.

Also arrested in this incident was Dana Dolan, 25, of Tilton, NH, who was apprehended at the Lancaster Police Department by two LPD officers. Dolan was

charged with Negligent Homicide; Manslaughter - Reckless; Reckless Conduct with a Deadly Weapon; and All Other Offenses.

He was arraigned on, Monday, March 1.

In that arraignment the state's attorney explained that there were two children in the car, while the three adult occupants were ingesting heroin and that the two toddlers were out of their car seats while the adults were asleep in the car.

Dolan was incarcerated until the trial.

# Editorial

## Everybody Reads

The first week of March is marked as Read Across America Week, and celebrates children's author Dr. Theodor Geisel, better known to the world as Dr. Seuss.

Dr. Seuss's birthday was March 2, the Saturday of winter vacation, so this is the week when most celebrations are taking place. And true to the famed children's author, school activities focus on reading.

While Read Across America Week was created by the National Education Association, no matter what people think of unions we hope everyone can agree on the importance of reading, and of reading to children - early and often.

Whether it's dressing up as the Cat in the Hat, creating green eggs and ham, serving as a "celebrity reader" in a local elementary school, or just cuddling up to your child to read a bedtime story, Read Across America reminds us of the importance of what could easily become a lost art in the rush of life today.

Yet there's not a more important factor in future success than the ability and the desire to read and not just texts. Most of us take it for granted and don't remember how we learned to read, but we use the skill every day. Research shows kids who spend

time reading do better in school. Whether it's by reading traffic signs or employment applications or college textbooks or exam questions, or the enjoyment of sitting by a warm fire and reading a book to relax for the evening reading follows us through our lives.

If your child's school asks you to spend a little extra time reading at home, go for it. In the midst of busy, out of control schedules, it will be time well spent. While you're at it, schedule a trip to the children's room at your local library. Seeing an entire building filled with books can open up yet another reading experience for your youngster.

So whether it's from Drop Everything And Read (DEAR) time in class, or awards given to students "caught" reading during the school day, Read Across America Week underscores the importance of the simple act of picking up a book and getting lost in its story. You can read on a Kindle, you can read on a computer, and best of all, you can read in a book. And when you read to a child, you're building memories for both of you.

As Dr. Seuss wrote, "You're never too old, too wacky, too wild, to pick up a book and read to a child."

## Vote No. on Article 14 - Redistricting

To the editor,

In a nutshell, Article 14: Urge the New Hampshire General Court for Transparent Redistricting is unnecessary.

Why? Because this is the case with everything the New Hampshire General Court (NH's Legislative body) already does. New Hampshire has the largest State legislature in the country and the most representative one. The Town of Londonderry has seven members in the House and one of the twenty-four State Senators. Every piece of legislation that is introduced, including those which deal with this very important redistricting issue, undergoes a duly-noticed public hearing, at which public input is invited and encouraged. All testimony is recorded and considered by the committee as it does its work to finalize a piece of legislation for the entire legislative body. Testimony can be submitted in writing, in person or both. This makes the process very transparent. As the Vice Chairman of the House Election Law Committee and a member of the newly-formed redistricting committee I, along with my colleagues, will strive to do our best to hear, consider and appropriately act on the concerns of all New Hampshire citizens. I am committed to performing my duties and casting my legislative votes in a manner that best serves all constituents.

Additionally, although public input is always welcomed, Part 2, Arti-

cles 9 and 26 of the New Hampshire State Constitution, specifically empower and require the New Hampshire Legislature to conduct redistricting every ten years, after the federal census has been taken. There is no authority for any other entity to implement or impact this process. If Article 14 should pass, legislators of the Senate and House will gladly acknowledge the results and consider that outcome, as we do all communications from our fellow citizens. However, it will not affect how we do our jobs, because redistricting in New Hampshire will be an open, fair, and just process regardless.

# Conservation Commission Recaps Musquash Field Day

While it was a short Londonderry Conservation Commission meeting on Feb. 22 on Zoom, the commission was able to cover a few important topics.

One of the items that was discussed and voted on during the meeting revolved around the Cross Farm expansion.

While the commission asked if there could be a commitment to not use phosphorus fertilizer.

It was explained that this would be difficult to do because the condo plans were already written meaning that they would need to get 67 percent of the unit owners to vote in favor of the amendment in order for it to pass.

Instead it was recommended to put the restrictions in the site plans meaning that the restriction would be a condition in the conditional use permit to expand.

During the meeting

Londonderry Geographic Information System Manager Amy Kizak explained that Benchmark Engineering added a note to make sure they are in compliance with the conditions.

The note states that units within phase 4,5, and 6 will not utilize fertilizer or lawn care products containing phosphorus. It also states that all winter salt maintenance in these phases need to be conducted by a Green Snopro certified applicator.

Kizak told the board that she needed a vote to approve the language of the note in the plan.

The board agreed that what was in the plan was what they wanted.

"The plan now states exactly what we wanted," said Marge Badois, the Conservation Commission Chair.

Another important item on the agenda that was discussed by the commission during the meeting revolved around the maps and signs at

the Musquash trails.

It was explained by Badois that at one of the last town council meetings a member in the community said that the maps at the Musquash trails don't match the signs.

After learning about this one of the members of the commission Mike Byerly said that he visited the sign in question and determined that there was indeed an issue with it.

"The map on the Kiosk is very old and doesn't match what is on the maps," Byerly explained.

While it wasn't determined during the meeting whether all the kiosks and maps didn't match up, Byerly explained that he didn't think it would be a bad idea to audit all of them this spring to make sure they are all set and they can avoid any confusion in the future.

"I don't think it's a bad idea in the spring to do an audit, take a map and check all the posts, to make sure there are no errors," Byerly said.

For now it was decided that Kizak would get the updated map printed and laminated to put on the kiosk board.

During the meeting the commission also recapped Musquash Field

Day, a major event that takes place every year.

Badois began the discussion by talking about how it wasn't the same event as usual because of the pandemic, but still turned out well.

"It wasn't the same as having our nice cook-out, but it turned out to be a pretty nice day," Badois explained.

She also explained that she thought the trails were in very good shape.

"I thought the trails were in fabulous condition. People had been out on snow shoes and it looked like we had pro-

fessionally groomed the trails," Badois said.

It was also noted during the meeting that the event attracted visitors from other towns including a conservation commission member from Derry.

Badois said that she was also pleased to see that people who never have been to the trails came for the first time during the event.

"I am always pleased when people come that have never been to the Musquash before," Badois said.

Commission member

Deb Lievens said that while people were at the event that she saw she spoke about next year's event, in hopes that things will be much different in a good way.

"I definitely talked up next year's event," Lievens said.

Overall Badois said that the event was a successful one.

"It turned out well," Badois said.

The next Londonderry Conservation Commission meeting is scheduled for Tuesday, March 9 at 7:30 p.m.

# Out-of-School-Time Grant Gives Career Pathways in STEM Fields

The New Hampshire Department of Education recently announced that the Granite State was one of four states in the country to receive a federal grant for \$2,943,000 through the U.S. Department of Education to help expand access to career pathway opportunities and prepare students for careers in STEM-oriented fields.

The New Hampshire Out-of-School-Time Career Pathways Initiative is collaboration between the Department of Education, Nita M. Lowey 21st Century Community Learning Center programs (21st CCLC) and the New Hampshire Learning Initiative (NHLI). Collaborative members will work with the Conway, Hinsdale, Laconia, and Manchester

school districts as well as industry partners in those areas, including Graphics, NH Aviation Museum, Eastern Slopes Aviation, Eversource, GS Precision, and EPTAM Precision. "This is a great example of a public-private partnership in which we align the interests of government, non-profit and business communities to benefit New

Hampshire students," said Frank Edelblut, commissioner of education. "These are the types of creative and innovative opportunities that will provide students and teachers alike the opportunity to grow and expand their horizons." Over the five-year program period, the initiative will build the capacity of the four dis-

tricts to deliver on supporting students to complete an industry-recognized credential for remote work, supporting students to complete STEM-related industry-recognized credentials chosen from a range approved options, and supporting students to complete paid internships in an in-demand STEM-related work-based learning opportu-

nity with a local employer. Additionally, students in grades six through eight in each district will have opportunities in a developmentally appropriate career learning opportunity and all districts will work to implement a career assessment process to be administered to all students at least twice during their K-12 learning journey.



## Lancer Boys Hoops Squad Finishes Season with Big Wins

The Londonderry Boys Basketball Squad finished the abbreviated COVID-19 winter season with two strong wins against the Merrimack High School Tomahawks both at home and away.
