## Right to Know Policy May Be Revised by School Board

At the previous School Board meeting, Superintendent, Dan Black, spoke about potentially revising their policy on right to know requests.

Black said while he understands wanting to get information to the

public quickly through electronic means, including email, he was worried about generic requests from outside entities. Currently, their policy is if a request is made, the information needs to be picked up at the District Office.

Ahead of their Dec. 13, School Board meet-

ing, Black said he met with Town Manager, Mike Malaguti, to learn what they do with requests.

Malaguti said it is somewhat different than the schools because many of the requests the town receives are for things like accident re-

## Town Council Make Plea for Additional Volunteers

During the end of the Monday night, Dec. 19, Town Council meeting, members had a number of reappointments to vote on and while doing so realized that more volunteers are necessary to fill out some of the town's boards and committees.

Before voting on a number of reappointments, council chair, John Farrell noted they haven't received any new resident volunteers for boards and is hoping some will come forward

in the upcoming year.

The Conservation Commission was looking for two, Three-Year Full Member Positions; one, Three-Year Alternate member; and one, Two-Year Alternate member. The board voted to reappointment David Heafey and Bob Maxwell, leaving two alternate seats vacant.

For the Planning Board, there were two, Three-Year Full Member Positions and one, Three-Year Alternate member positions expiring. All were taken by existing members. Al Sypek and Lynn Wiles

will retain the full-member seats and Roger Filio retained his alternate seat.

For the Zoning Board of Adjustment (ZBA), there is one, Three-Year Full Member Position open; one, One-year Full Member Position; one, Three-Year Alternate member position; and one, One-Year Alternate member needed.

Although the board voted to reappoint two members to full member seats, they had one resignation. Alternate member, David Armstrong, resigned from the ZBA,

## Plans for Water Tank on Gordon Drive Gets Okay

The Londonderry Planning Board opened a public hearing for a water tank located at 7 Gordon Drive at their Dec. 7 meeting. The project has already been in front of the Heritage and Conservation Commissions.

The proposal was for a 6,709 square-foot water tank with a transmission water main to be put between Gordon Drive and Marketplace Drive. Trevor Yandow of Meridian Land Services was at the meeting with Mark Filion of Penichuck Water to make the presentation.

"The tank is 35 feet in height, and the diameter is just under 93 feet," outlined Yandow. "The site will be enclosed in a perimeter fence, and it will be gated."

Their plan also included a small runoff area for the treatment of runoff and a few waivers regarding the right of way for the site.

"The transmission main exits in the southwest part of the tank and crosses Spring Road," said Yandow, describing the piping to the tank. "There are some existing wetland areas we're working around. There's no feasible way to access the site without

coming through some wetlands."

He hopes to minimize the wetland impact through precise drilling for the water lines. The lot will also serve as a booster station.

The original plan was for a 156-foot water tower in the area, although this was later revised to a shorter tank out of aes-

# Plan For Rockingham Road Gas Station/Store Gets Continued

The Planning Board reviewed an application for formal review of a site plan amendment for the construction of a proposed 6,000 square foot convenience store with a drive through, along with a gas station with 16 fueling stations and three diesel fueling stations during their Dec. 7 meeting.

Earlier this year, the properties, which are located at 174 and 178 Rockingham Road, were given a conditional use permit.

One of the items that still needs to be sorted out, John Trottier, Direc-

tor of Engineering and Environmental Services said, is the traffic coming in and out of the site.

"This evening staff isn't recommending conditional approval of this plan," said Trottier.

Karl Dubay, the third party traffic engineer assigned to look at the plan, said they aren't done with working with the applicant's traffic engineer when it comes to addressing traffic concerns.

The biggest question Dubay pointed to is how it would work with people coming in from two different driveways. The other issue is when it comes to traffic from the drive through. He added

that there are still comments that need to be addressed.

It was explained by Town Planner, Kellie Carron, when they have a site plan they send it out for review and part of it is reviewing how many "stacking spaces" they have for the drive through as well as how those cars would navigate on the site. She said ultimately while they may have the 10 spaces required, there are other factors that need to be looked at.

Planning Board member, Lynn Wiles, said he thought it was strange they would require a non left hand turn drive on to Symmes

Drive.

"I think that's an odd requirement to have," said Wiles.

Jeff Kevan from TF Moran explained that because of the bus station in the area and the driveway directly across to the north, it was a concession made during their previous application.

Ex-Officio, Deb Paul, said she lives in the area and said the "traffic is horrible."

"My biggest concern is the traffic," said Paul.

She explained she also recommended they look at doing something to improve pedestrian safety for those who will walk there.

During public comment, Ray Breslin, a community member in town, spoke saying he was also concerned about traffic, noting there are different projects in the works in that area that will likely increase traffic.

"We need to look at the future here," said Breslin.

In terms of signage, Kevan said they would be looking at having more signs than allowed, which they would need to get a variance for from the ZBA, along with the height of the standalone signs.

"Signage would have to conform to your regulations," said Kevan.

Kevan said they would have 51 parking spaces in total, three more than what is required, and would have about 46 percent of green space, which is more than the 33 percent, required.

After hearing from the Heritage Commission, it was also decided to go with exterior materials that are a "more traditional New England" palette.

It includes architectural asphalt shingle roof, a brick base, clapboard siding, and wood siding at the main entry.

The decided to continue the application was until the Wednesday, Jan. 11, meeting.

# School Board Members Review District's Athletics Budget

The Londonderry athletics department budget was discussed during the Dec. 6 School Board meeting.

Athletic Director, Howard Sobolov, gave the School Board an overview of the department saying they cur-

rently have 81 teams between the high school and middle school and had 418 athletes during the fall at the high school and 305 at the middle school.

He said it is up from 248 at the middle school last year mainly due to the addition of the football team.

"75 more kids in the

school got to participate in athletics at Londonderry Middle School," said Sobolov.

Overall, Sobolov said they were looking at a total budget of \$422,386, which is an increase of about \$11,000 compared to last year.

For game officials at the two schools, Sobolov said they were

looking for an increase of \$3,525.

He explained it reflects the amount spent last year, plus fees for the two new teams they added along with the official fees going up \$2 per game.

For their repairs line, Sobolov stated they were looking for the same as last year for a total of \$13,000. He added that it includes things like reconditioning of helmets and shoulder pads or helmets.

One of their biggest expenses is for rentals. Sobolov said they were looking for \$81,800, this year, which was an increase of \$6,500 over last year.

Sobolov said they based it on this year's

actual costs along with increases in rental fees. He said it mostly had to do with increases in chemicals at the pool along with rental ice going up in price.

For uniforms, Sobolov stated they were looking for a total of \$23,075, a decrease of \$3,025 of last year's budget.

Sobolov said they also went with a "better" online registration service, which is a little more expensive.

He explained it also covers the costs for end of season tournaments and licenses for coaches and league fees.

In addition to the operating budget, Sobolov stated they were proposing to add an electronic timing system for

the high school to be added to the capital reserved fund for a total of \$17,995. He added they are needed under state guidelines for all cross country and track meets.

School Board Vice Chair, Sara Loughlin, asked about the mini buses and what they are used for.

Sobolov explained they are used at times for smaller teams that have 14 or less athletes like tennis, cross country, golf, or for things like specialty track teams where the full team doesn't attend.

It was explained by Sobolov that coaches can volunteer to become certified to drive the buses for free.

# District's Tutoring Policy Review by School Board

The school district's tutoring policy was discussed during the Dec. 13 School Board meeting.

It was explained by School Board Chair, Amy Finamore, that she was reviewing policies recently and noticed the one regarding tutoring.

The current policy states, "It is Londonderry Public School policy that no teacher may receive pay for tutoring

one of his own pupils. A teacher should also avoid tutoring any child from his building. All questions regarding tutoring should be referred to the teacher's building principal."

"The above does not apply to home bound instruction assigned by the school administration."

She noted the current policy doesn't have any mention of female teachers.

"I think there is some

language in this policy that should be updated to reflect males and females teach and not just males," said Finamore.

Finamore also noted it states that a teacher can't tutor any of their current students or students inside the school. She added that it means students and parents have to find tutors from other districts.

She stated she was looking to see if the rest of the school board would be interested in revisiting the policy.

Superintendent, Dan Black, explained that the

spirit of the policy is that none of their staff members could ever be accused of using their position to try to make money outside of their teaching role.

"They wouldn't do that, but I think that's where it comes from," said Black,

Black said he thinks there are ways to make changes to the policy that don't change the spirit of the policy.

School Board Vice Chair, Sara Loughlin, said she thinks they need to be careful with the language so it doesn't seem like it means

things like helping a student after school.

She also suggested they make it so they could tutor students inside the school, but not their own current students.

"I actually like that idea a lot," said School Board member, Kevin Gray.

Finamore said she thinks they should be able to offer tutoring over the summer, for example, if a student is going to be in a particular subject and the parents want to have their child tutored by the teacher they are going

to have, then it may not be a conflict.

Loughlin said she thought it would be okay during the summer.

"I think the summer time is okay," said Loughlin.

School Board member, Amanda Butcher, said she didn't think it should be for a student currently enrolled in the class, but summer could be different.

The School Board approved having the district administration review the policy and to draft a revised policy for their consideration.

thetic concerns.

"Our water system needs storage," added Filion as he summarized the importance of a new water tank. He also emphasized the importance of redundancy in the town water system. They claimed it could provide Londonderry residents with water in case of a mainline break while improving water pressure.

The Planning Board quickly accepted the

application as complete without debate, before opening the matter to discussion.

"Are you familiar with the tanks on Josephine Drive, and would these be of similar construction size and capacity?" asked Board Member, Bruce Hallowell. Presenters confirmed that the Gordon Drive should look similar with a capacity large enough to compensate for a potential water shortage.

Board Member, Giovanni Verani, recommended making some

visual changes to the project, allowing it to fit into the surrounding area. "My biggest concern is how does this impact abutter's land. You should load it up with trees and minimize the impact on the neighbors."

Although the plan currently only shows five trees, presenters were open to more extensive landscaping, while changing the coloring to an earth tone. They also promised the water tank would not produce noise.

Abutters, Rachel and

Michael Lessard, were at the meeting to chime in on the plan to add foliage. "The trees in that area are all falling over, it's not as dense as it used to be," said Racheal. "I just don't want to be looking at a water tank," added Michael. Similar concerns were expressed by other abutters, with some frustration from those on Gordon Drive.

The Planning Board unanimously voted to grant a conditional use permit for the Gordon Drive water project.

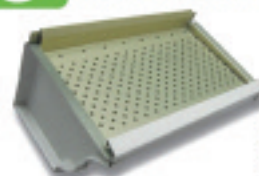

Congress to address natural gas/diesel supply shortages in the Northeast, rising energy costs, and develop a plan to prevent rolling blackouts should the region experience frigid temperatures this winter. ports, or land use documents, which don't have as much sensitive information to be reviewed before sending out.

Black stated after meeting with Malaguti, he still thinks they need to keep their policy in place.

"The dynamics have not changed," Black said

in a memo. "What the school district needs for protection in our policy is that we do not have a requirement to "transmit" the documents once they are compiled for the Right to Know requests electronically. If we can avoid that requirement, we would be able to keep the frivolous Right to Know

requests that come from outside the Londonderry community at bay."

He told the School Board they would be able to provide the information from Right to Know requests if they provide a flash drive.

"We can easily upload all of the paperwork that might be generated from a Right to Know request in that manner, and we have

done it in the past," said Black. "In theory, we can do this with Right to Know requests that come from outside of Londonderry, assuming the person that asks for them shows up in person. That action is what protects us from the frivolous nature of some of the Right to Know requests that come our way."

School Board member, Bob Slater, argued that anyone can request a 91A and when that happens the work still needs to be done. He added that whether someone shows up and

picks up the information or not is another story.

He also noted that he looked at four other school districts, including Manchester, which allows for the information to be sent by email. He said they also allow in their policy for information to be put on a thumb drive.

"Pretty much every district has the option with the thumb drive," said Slater.

Slater also noted he doesn't want to take up their staff time while they have to review it with people who request the information saying

that it sometimes takes hours.

He said he ultimately wants to be able to get the information out as fast as possible.

"It's all these opportunities to show the community we have nothing to hide," said Slater.

He stated that if they don't have it electronically then they don't have to provide it that way.

The School Board voted 4-1 in favor of having a new policy drafted with Finamore voting against it.

# School Board Approve Understanding With Hooksett

School Board members discussed and approved the Memo of Understanding (MOU) with the Hooksett school district during its Tuesday, Dec. 13, meeting.

"Londonderry High School currently has a Memo of Understanding with Hooksett, which enables us to accept

Hooksett students as space allows," Business Administrator, Lisa McKenney, said in a memo. "We have been receiving students from Hooksett as far back as the 2013/2014 school year."

With the MOU ending in June, the school district administration was looking to sign a new five-year agreement.

Superintendent, Dan Black, said during the meeting that the Hooksett School Board agreed to match the tuition for Pinkerton.

This year, that amount is \$12,500 per student and in FY 24 will be \$15,408.

"They agreed to it," said Black.

Another major change that Black pointed to is

in terms of transportation.

"The language in the MOU will allow for Londonderry to provide transportation at our discretion. We would make a bus available if the income from the number of students needing transportation surpassed the expense of the bus," said McKenney. "Currently there is one bus route to Hooksett at a cost of \$62,734/year. By providing one bus, we were able to increase the number of students opting into enrollment at LHS."

McKenney said that right now they have 122 Hooksett/Auburn students. Next year they budgeted for 109 students, for a total of \$1,679,472. She added that the revenue offsets the local property tax rate for education by thirty-two cents. This produces a savings of

\$128/year on a \$400,000 house.

"Londonderry taxpayers and the Londonderry School District both benefit from this arrangement. We are able to collect revenue for otherwise empty seats in our classrooms," said McKenney. "The schools have fixed costs; salaries, heating, and lighting that would not change if we accepted these students or not. By accepting these students, there is an average savings of \$128/year to the local taxpayer."

It was noted by McKenney that they aren't obligated to bring in any students in if there isn't room.

"Under this agreement, we are under no obligation to accept these students if we do not have space," said McKenney.

Londonderry resident Kristine Perez, stated she was concerned with a potential recession and what it could mean to state aid along with many apartments going through the Planning Board process, and how that may impact their enrolment.

"We're talking about 350 plus apartments," said Perez.

School Board member, Bob Slater, noted they are under their optimal capacity for the high school, and the agreement helps to offset the tax rate.

"We do have that room for a much larger capacity in this town," said Slater.

He said they might have to look at the MOU in the future depending on enrollment.

The School Board ultimately voted 5-0 in favor of the MOU.
