On Monday, April 15, 2024, Mary Kathryn Calawa, devoted wife and beloved mother of four, passed away at the age of 62, after a seven-year struggle with posterior cortical atrophy, a rare variant of Alzheimer's. A loving spouse, mother, church leader, and friend, Mary blessed everyone she met through her attentive hospitality, vibrant conversation, and selfless service.

Mary was born in Illinois on Dec. 12, 1961 as the oldest daughter to Richard and Maggie (Rupp) Lyons, and moved to Hamilton, MA a few years later. Mary was a high-energy, high-capacity woman who proudly embrace her role as a wife and mother. She stayed at home to raise her children, homeschooling them for many years, and was an active part of whatever her kids were involved in. Mary was also incredibly involved with her church and local community. She led a women's bible study program for many years at Londonderry Presbyterian Church (LPC) and was the "Sing and Play lady" for almost 20 years of Vacation Bible School between her time at LPC and Orchard Christian Fellowship. Outside of church, Mary ran a bookkeeping business and served as a volunteer treasurer for the Londonderry High School Friends of Music. Mary loved cheering on the Patriots and Red Sox, reading, visiting the beach, getting ice cream at Mack's Apples, and dancing to "Sweet Caroline." But ultimately, Mary's two greatest loves were Jesus and her family.

Mary will be lovingly remembered by her husband, Marty, her four children and their spouses - Kathryn (Chris) Meier, Jennifer Calawa, Christian Calawa, and Kelly Calawa - as well as her first grandson who is due in June. She is also survived by her mother, Maggie, her siblings - Dick (Kathleen) Lyons, Kimberly (Andrew) Cullen, and Susan (Chris) Schultz - along with her aunt, Kathleen Rupp-Utera, and many other extended family members. She was preceded in death by her father, Richard Lyons and her brother, David Lyons.

The family gives special thanks to our church family at Orchard Christian Fellowship for their practical demonstration of Christ's love in caring for Mary and our family throughout her disease. The family also thanks the staff at All American Assisted Living and Memory Care of Londonderry and Brookhaven Hospice for their exceptional care of Mary in the final months of her life.

### **Developer Proposes Extension to Mount Vernon Drive for Driveway**

Commission met on April 9 to hear a presentation from Doug MacGuire from the Dubay Group, who was representing the landowner of 8 Wiley Hill Road. They plan to extend Mount Vernon Dr., opening access to the nearby Wiley Hill property and making development easier.

MacGuire promised "I noticed that one of to limit the rip-rack rock needed and thought filling in gaps between the rocks would not be much of an issue.

> "This isn't going to be the large, 12-inch rock, it's going to be the smaller stone so it would be fairly simple to add in that additional material between the stone. We can do that on all the crossings, anywhere we put rip-rap, it's not an issue," he said.

The Conservation Commission is scheduled to meet again on Tuesday, May 14, at 7:30 p.m. in the Moose Hill Council Chambers.

# Editorial

### Still Waiting for the Relief

A number of years ago, Nutfield Publishing came out with an editorial on economic development and growth in our communities. At that time, Officials proudly announced that they believed "rapid development was the magic pill towns need to curb rising tax rates.'

Unfortunately, more development wasn't the magic pill back then, and it isn't now. Just as back then, the long-term costs of compensating for this development are continuing to add to the overall tax burdern. Increased salaries of more municipal employees, significant raises and the ever increasing bottom line, all in addition to taxpayer-paid benefits, have led to a situation where costs continue to rise, aging infrastructure may continue to fail, and the demand for "services" remains unchecked.

Now, we understand the hard work required to craft budgets that respect the taxpayers' dire financial straits, and we believe the beacon of economic development, growth, and change can still shine as a goal for the long-term improvement of our communities. #### **Records of Public Meetings**

To the editor,

At the March election, the residents expressed great concern about the lack of transparency and of public input at various Town meetings. They also exall meetings recorded.

A recent Heritage/ Historic District Meeting was not recorded for either technical or staffing reasons. Consequently, the only record that the public has is from the minutes of that meeting. The draft minutes are available and they accurately reflect the summary of events, as far as I can recall. However, being minutes, they cannot provide the level of detail that might be required if an item were raised again in the future. For example, in public comment, I raised several points.

My comments referred to an eMail sent several weeks prior concerning the barn condition at 2 Litchfield Road. As minuted. I was informed that the owner had retained legal counsel and so the H/HDC was unable to comment. I was invited to speak. I presented pictures from 2007 and 2017 that showed some maintenance and preservation had been ongoing by a previous owner but that since 2017 the barn had been allowed to deteriorate. I pointed out that this is the only English barn in Town that is protected and that its condition was established in a report by the NH Preservation Alliance. I noted that the H/HDC is supposed to investigate when such a deficiency is brought to their atten-

### Why Wait

To the editor,

We were discussing pressed a desire to have why people do not take advantage of the AARP Home Fit Guide at a recent Senior Resource Committee meeting and it was suggested that we only fix to our homes after we have an accident or other medical need. So, why not make the fixes before the accident and avoid the unnecessary cost and pain.

> Aging in place is the ability to live independently, comfortably, and safely in one's own home or community. There are many factors that one should consider as we make our individual decisions as we enter our 70's and beyond. I would like to take this opportunity to mention some things that could make the decision easier.

The first is information that will help make your home safer and help prevent the injuries from falls that limit our mobility and may require expensive medical treatment. The AARP Home Fit Guide is one of these (www.AARP.org). It is a room by room guide to making your home safer. Many of the suggestions are low cost. Others are more expensive but may be worthwhile if we consider the cost of assisted living or other options. Here are some of their recommendations.

Low-Cost Safety Tips: Bathroom Safety. Add textured, no-slip strips in the bathtub and shower, apply nonslip wax on

tion and, if necessary, to floors, place a waterproof seat or chair in the shower, use rubberbacked bathmats, and consider replacing the toilet with a raised or high-profile toilet.

> General Safety: Remove wheels from chairs avoid accidental movement, replace standard doorknobs with lever handles for easier use, eliminate or secure area rugs to the floor to prevent slipping, put nonskid treads on steps, ensure good lighting in hallways, stairs, and paths, and replace standard doorknobs with lever handles for easier use.

> Expensive Changes (may require professional help):

> Alter the shower for walk-in access (no stepover entry), create zerothreshold entryways. move light switches to easy-to-reach locations from a wheelchair or bed, and widen doorways and hallways.

> Finally, the National Association of Home Builders has a Certified Aging in Place Specialist training and certification program and an Aging in Place Remodeling Check List that is much more extensive than that provided above.

It also states that no nursing mother "will be discriminated against for nursing or nursing related activities as provided in this policy, and reasonable efforts will be made to assist nursing mothers in meeting their infant feeding goals while at work or school."

As part of the policy, it states that a "nursing or expectant mother should contact the building principal or employee's supervisor at least two weeks before the need for nursing accommodations arises."

"The District will endeavor to meet the break and space needs of each nursing mother. However, when ordinary accommodations (as discussed below) will create undue hardship to the operations of the school/ workplace, the District will work with the nursing mother to determine whether other acceptable accommodations may be made. Such other accommodations could include such items as a change in work/class assignments, or schedules," the policy states. "When acceptable accommoda-

means," the statement the building principal or other administrator working with the nursing mother should consult with the District's Human Resource Director."

> The policy states that a nursing accommodation plan "should be revisited upon the nursing mother's request, or at least every three months, with adjustments made to the accommodations for breaks as nursing needs change."

> In addition to a number of accommodations that need to be made as part of the policy, the policy also outlines prohibited conduct.

"Any intentional act which violates a nursing mother's privacy, aims to frustrate a nursing mother's intentions to use the nursing facilities, or constitutes harassment on account of a nursing mother's needs or breastfeeding status is prohibited, and shall be treated as violation of the applicable code of conduct, with possible disciplinary consequences and may constitute sexual harassment and reported to the Title IX Coordinator." the policy states.

The Board unanimously approved the policy.



the Town Council to lead the town's effort to expand the water sys-

"There's a lot of good activity going, it's a good team, a lot of diverse skills, and I think we're making some good progress," said McGraw.

Much of the information gathered will be sent to engineers with more experience on deficiencies in the Maswhat the design of an

expanded water system could look like. The Committee will talk to Pennichuck Water's new CEO John Boisvert in the near future on the issue of new water lines and hopes to coordinate with the Planning Board to add their developing water strategy to the Master Plan.

"I think one of the ter Plan is the lack of a water plan," said Wiles. "It's timely that we're doing this.'

Funding has already been set aside to revise the existing Master Plan.

The sewer and solid waste subcommittee looked into looking at the sewer facilities plan, which has not been updated since 2013. According to the Chair, some elements of the plan were even more out

of date.

"The current rate structure is from 2007," Wile explained. "The rate structure hasn't changed in 17 years. Right away, that tells you something's a mess with that."

No immediate action was taken on a proposal to merge sewerage with

the water subcommittee or on a proposal to add recycling to the solid waste subcommittee from the March meeting.

The Utilities Committee is scheduled to meet again on Tuesday, May 7, at 7 p.m. on the first floor of the Moose Hill Council Chambers.

She explained South School and Londonderry Middle School are expected to be scheduled for this summer, and the High School "should be complete by Summer 2025," according to Mc-Kenney.

"Included in [Londonderry Middle School] and [South School] upgrades are control upgrades that will be supported by ENE Systems," McKenney told the School Board in a memo.

For the FY25 school year, she explained after some discussion it was decided to propose to move the service agreement "for these two schools to ENE Systems of NH and maintain our service agreement with schools."

This will allow our staff to transition to the new platform for the controls," McKenney said.

It was explained by McKenney that all the other schools could move to the new platform in FY26.

ENE Systems is expected to cost them \$21 750, for Londonderry Middle School and South School.

Meanwhile, Siemens would be the provider for Londonderry High School, Londonderry High School Gym, Matthew Thornton, North School, and South School, for a total contract of \$38,900.

"The total for both contracts total \$60,650," McKenney said.

She said the quote for all the schools for FY25 for Siemens was \$70,983, and noted they would have a savings of by splitting it up.

It was also noted by McKenney that "included with the HVAC Infrastructure work at South School, the underground oil tanks will be removed and replaced with propane tanks."

"Our contractor EEl bid out the tank cost and we received four bids for propane tanks (which is included in EEI contract), but there is a propane purchase agreement with the quote that we are responsible for," McKenney wrote in a memo.

She said the recommended bid was with Rymes, giving a bid of \$1.549 per gallon, with an estimated 23,308 gallons needed for a propane cost of \$36,104.09.

No objections were raised by the Board and was agreed to allow McKenney to move forward with the proposal.




