Recreation Budget Reviewed During Kick-off Workshop

At the Town budget kickoff workshop meeting, the Londonderry Town Council and Budget Committee heard from Recreation Director, Art Psaledas.

"Our rec budget is increasing and the rea-

sons for this, it's a fairly simple one, we have an aging system," he said. The proposed budget as of now is \$ 273,122.00 - which is \$33,469 more compared to the FY 25 budget of \$239,653.

It was also noted that the proposed budget is \$17,370 more than the

Default Budget as of now. Psaledas explained that the West Road facility opened in 2002, which was 22 years ago.

It was pointed out by Psaledas that this past year they have had six breaks for the irrigation, and they also had to

Temporary Moratorium on Development Discussed

The Planning Board had a brief discussion regarding a potential temporary moratorium on development during its most recent meeting.

"We need to discuss it, we need to talk about it, we need to bring it up," Planning Board Chair, Jake Butler, said.

He explained they are in a "unique time" right now explaining that in the past year, they have had over 1,000 units either approved or actively being worked on.

Butler explained that they have infrastructure issues that they need to address along with

staffing issues as well.

"We have a lot of things that need to be addressed," Butler said.

Butler stated he also wants to make sure that they are doing the right thing for the town.

"I want to make sure we are doing the right thing for the town of Londonderry," Butler said.

Butler explained that they had the Town Council reach out to the Town Attorney, to see what they could do about having a temporary moratorium, saying that he thinks they are in a unique situation.

It was also noted by Butler that the Town Attorney wanted to meet with the Board in the

near future.

Planning Board Vice Chair, Art Rugg, noted that it would be a non meeting with the attorney to discuss how they feel about it and to see what would be allowed.

Planning Board member, Lynn Wiles, said he thinks they need to discuss the possibility of one, and said they need to hear from the Town Council on how they can proceed.

Planning Board ex-officio, Giovanni Verani, said he thinks staffing needs to be addressed independent of a proposed growth moratorium.

"I think that starts

Questions Being Raised on Status of Malaguti & Town

The recent resignation of Londonderry Town Manager, Mike Malaguti, may not have been a shock to many of the residents in town, but it came just six-months after a three-year contract extension.

The Town Council and Malaguti negotiated a new contract in April of this year on a contract that wasn't due to expire until Feb. 25, 2025.

Between his newest contract and an amendment given to him in July of 2023, Malaguti received a \$14,375 raise

from his original salary of \$130,000, and it also extended the termination lump-sum payout from four to six-months.

The contract did however state that if the Town Manager resigned, he would not be entitled to a payout,

"In the event Malaguti intends to resign his position with the Town before the expiration of the term of this Agreement, he shall provide the Council with advance notice of not less than 60 days. In the event that Malaguti resigns as Town Manager, he shall not be entitled

to payment of any severance, compensation or benefits. In the event Malaguti fails to provide the Town with advance notice of his resignation of at least 60 days, Malaguti shall pay to the Town a lump-sum cash payment equal to two month's' aggregate salary

Subdivision in Consent Decree Triggers Well Quality Concerns

The first November meeting of the Londonderry Planning Board included a proposal to create seven residential lots at 8 Wiley Hill Road. The Board heard from Engineer, Doug MacGuire, of the Dubai Group to get more details on the subdivision.

"It's a proposal for standard, subdivision lots," said MacGuire. "This property has legal frontage on Wiley Hill Road, it does have approximately 100 feet at High Range Road, and it has additional frontage of an intentionally dead-ended cul-de-sac Mont Vernon Drive, which ended at the property with the potential of an extension."

The proposal would extend Mont Vernon Drive by about 475 feet to serve four of the seven homes and change the current hammer-head-style dead-end on Mont Vernon into a larger turnaround.

The property had an extensive wetland sys-

tem in the area, with calls to reduce the impact construction would have on the environment by reducing sloping and runoff when possible. Other suggestions included marking wetland buffers and minimizing the use of riprap and possible preexisting environmental contamination.

"This development is within the consent decree area for Saint-Gobain," noted Board member, Lynn Wiles. "Have you had any discussion with DES over their concerns about drilling wells and who's going to be responsible for the maintenance of those wells after they've been installed?"

Any future wells would need regular testing, MacGuire responded by saying that there was no specific conversation about wells with state regulators and that they would need to address the problem on a "lot-by-lot basis." He did not see any reason why the issue would prevent the property owner from developing the Wiley Hill lot.

It was unclear whether Saint-Gobain would be responsible for covering the cost of well filters and monitoring for new homes, even those in the consent decree.

Abutter, Brian Donovan, of 7 Carousel Ct. was worried about the negative impact of having a new two-story house close to his backyard.

"For anybody who says that doesn't affect my property value, I think that's foolish," said Donovan. "I'm in the process of moving into my retirement, downsizing, I'm going to be selling the house in four to five years."

He asked the applicant to consider screening or fencing to protect the privacy of those living in the area.

Ann James of 16 Wiley Hill Rd. was worried about increased traffic in what had been a quiet part of town.

"It affects me phenomenally as far as traffic goes. I could stand on my street when I first

moved there, I wouldn't see a car," she said. "There has to be some concern for the people who live on that street and we're afraid to go to our mail boxes. It's getting worse by the day and I'm not quite sure why sure why we need to build on every open space in town."

Board Chair, Jake Butler, was sympathetic, but reminded her the Planning Board had to follow local regulations.

"We can't necessarily tell somebody no just because we don't like it," said Butler. "I don't want us to forget was good has happened and the land that the town has been able to purchase."

Multiple residents were worried about their wells and well water.

"My well is my main concern with blasting that could happen," said Doug Fuller of 2 Mont Vernon Dr., who had his well collapse after near-

by blasting a few years ago. "My residence and water quality could be affected."

MacGuire did not expect blasting to be necessary.

Ultimately, the Planning Board agreed to delay any possible approval or rejection pending legal review over whether houses built in the plan would fall under the conditions of the Saint-Gobain consent decree.

Public Works Outline Increases in Upcoming Budget

Londonderry's Department of Public Works made its formal presentation at the Nov. 2 budget meeting. DPW Director, Dave Wholley, was at the meeting with Director of Engineering and Environmental Services, John Trotter, to outline their budget requests for the coming year. There were a variety of small spending increases, with a focus on new water system infrastructure.

"Woodmont will be a pump station that will be

constructed just east of the intersection of Gilcrest and Pillsbury Road," said Trotter. "There's a lot of water that's being constructed in the town of Londonderry."

The cost of the station was \$2,600,000 in both the fiscal year 2025 and 2026 budget. The station will accommodate an additional 500,000 gallons of additional wastewater volume per day, an amount the Director of Engineering believed was necessary to accommodate homes and businesses connected to the town

sewage system. Members of the Town Council and Budget Committee briefly discussed ways the town might handle the expected increase in water services, including the creation of a new water division, though no such changes were likely in the near future.

The Highway Division saw a request for a spending increase from \$4,928,522 to \$5,240,614.

"It's used to maintain 191 miles of road, seven bridges, approximately 4,800 drainage structures, catch basins, end

sections, headwalls, and approximately 163 miles of drainage pipes," explained Trotter. "There's increases to three line items: department supplies, snow removal services, and the hydrant services."

Wholley emphasized a desire for DPW resources to be geared towards "safety, training, and personnel."

"We will be discussing a new \$8,000 request for training, and additional \$15,000 request for snow removal services, and a new \$150,000 request for work zone safety services," he said. "All three components are focused on preserving and protecting our current employees while preserving our ability to

fill vacancies quickly."

He complained DPW staff members were already overburdened and that they regularly had to work overtime hours to keep up with townwide repairs. He wanted to focus more on training as the town has struggled to find licensed candidates to fill vacant roles like CDL drivers, especially with snow removal, where DPW wanted to contract better equipment. However, the most significant focus was finding ways to improve worker safety.

"Currently, our department is not specifically funded to hire police details when we set up work zones to perform tree work, shoulder paving operations, and

other important maintenance tasks. We use two of our employees to function as flaggers," said Wholley, adding that drivers respond more to police, who have the power to enforce existing work zone laws. "With us performing traffic control, we have no legal authority to deal with violations or write citations."

DPW also wanted the funding to buy or rent physical safety items like Jersey barriers for longer projects, shoring devices for trenches, and other items deemed too costly. Wholley hoped approval of safety requests would "improve the way we look while we're out on the roadways" in the face of impatient drivers.

replace the control panel noting that it lasted longer than it was supposed to.

Psaledas also explained that the tennis courts haven't been resurfaced in eight years.

"We have put that on the backburner," he said.

Psaledas also said they have seen an increase for the number of participants in baseball, softball, and soccer.

"Soccer now has 900 kids playing," he said.

Psaledas said that they are also looking to re-strip the lines for the parking lot saying that the estimate for it is about \$5,000. He said that they haven't done it in six years.

"We're asking for money to try to maintain

what we have," Psaledas said.

Psaledas also noted that they save an estimated \$40,000 to \$50,000 each year for servicing the fields with volunteers.

"We need to maintain it so we don't lose it," he said.

Psaledas also explained that now that they have an assistant recreation in place, they have increased their number of programs. "He's done a bang up job," Psaledas said.

"They've been extremely well received by the town," Psaledas said about the recreation programs.

Town Council Vice Chair, Ted Combes, asked for them to be able to come front of them at some point to discuss everything they would like to see fixed or im-

proved at the facilities.

Another increase Psaledas pointed to is 10% for salaries mainly due to having an additional counselor for summer programming and for additional hours for maintenance.

Finance Director, Justin Campo, said they added an additional counselor that will be added to the budget.

"For safety reasons, we needed an additional counselor," Campo said.

Campo also explained that they have been discussing the possibility of moving recreation programs to a revolving fund so taxpayers as a whole wouldn't be responsible for paying for it and instead would depend on those who participate in the programs. Campo said the one thing they need to be cautious of is it being self-sustaining.

Regarding Our Now Ex-Fire Chief

To the editor,

It seems that the Town of Londonderry is all abuzz lately regarding the abrupt resignation of our now Ex-Fire Chief. Although the events which precipitated his departure appear to be fairly clear, there is much talk about how to remedy the consequences of those events as well as to possibly have him reinstated as Chief. Now let's cut to the chase.

Town management saw the need to reduce the budget, and one of the ways they saw fit to accomplish this was by eliminating newly authorized, additional positions in the Fire Department. Apparently, the Chief was directed to reduce staffing levels to a number he felt was insufficient. When the Chief couldn't get his way, he resigned in protest. I believe he did so at the Town Council meeting of Oct. 7. (I was at Town Hall that evening but did not stay for his presentation.) Apparently, this was a well-orchestrated presentation and there was a large number of Londonderry firefighters present, both in and out of uniform, along with many pieces of Londonderry Fire Department apparatus (to include fire engines, aerial tower, ambulances, etc.)

Fast forward to the Oct. 21, Town Council meeting and the minutes reflect many folks getting up to speak during the public comments period. Most spoke of what they perceived as the Town's unfair treatment of (now Ex) Fire Chief Bo Butler and demanded that things

be remedied to the Chief's liking. You can be sure there will be many more comments and letters-to-the-editor in this, as well as other publications. This seems to be a very emotional issue.

During his resignation "presentation", Butler spoke of, among other things, being "asked to make budgetary cuts and difficult decisions". (NHUL 11-5-24) Well, guess what? Management often has to make difficult decisions and that's what good managers are expected to do. I do not question the Chief's leadership skills, as one of those skills is to always look out for the well-being of your followers. BUT, leadership and management can be two very different things. Oftentimes the best of leaders are also the best of managers, but certainly not always.

I the purpose of this letter is not to make excuses for, nor malign anyone, but sometimes we must take the emotions out of the equation. Although I've never met (Ex) Chief Butler, I have heard him speak at several Town Council meetings and it appears to me that his theme is always of an emotional nature. That's okay sometimes, but it should not be in the mix for management decisions. Facts and figures, not emotions, are what good management is primarily based on. When a manager resorts to something akin to "If I don't get my way right now, I'm going to take my ball and go home", that's not my idea of good management. That's bad behavior, so let's not reward it, because

behavior rewarded is behavior repeated.

And remember, whenever management decisions are based on emotions, there will very likely be costs (= taxes) involved.

with the Town Council to hire a Town Manager," he said.

He noted that there is a housing crisis going on, and that Londonderry is in a favorable location to build.

"There is a huge housing crisis out there," Verani said, noting that they should look at smart development.

Planning Board member, Ann Chiampa, said they have done what they can to help address the housing issue, and she thinks it's time to

look at a temporary moratorium. She also noted that they have had one in the past.

"I think this is time, we need one again," Chiampa said.

Planning Board mem-

ber, Jason Knights, said he thinks they need to look at what their plan is going to be if they do a temporary moratorium. He also agreed that staffing issues are out of the Planning Board's

control.

Planning Board member, Jeff Penta, said the "timing is unique" and thinks they have overall infrastructure needs.

Sylvia von Aulock from the Southern NH

Planning Commission, who has been helping in the planning department, said a temporary moratorium is not out of the question.

"I'm glad you're talking about it," she said.

ary, representing liquidated damages, as any calculation of damages would be difficult to ascertain."

During his somewhat short tenure as Town Manager, Mike Malaguti has seen 11 positions vacated at Town Hall. Those positions were either terminated or the employees chose to leave.

The positions include: The recent resignation of Fire Chief Bo Butler; the elimination of the Associate Town Planner, Laura Gandia, let go Jan. 17, 2023; two Town Planners; two land use assistants; two Executive Assistants to the Town Manager; a GIS Manager/Comprehensive Planner; an Assessing Assistant and a Payroll Clerk.

Laura Gandia and her husband, Chris Gandia, were severed with a No Trespass Order on Jan. 26, 2023 by Malaguti shortly after her termi-

nation.

One year ago, Malaguti and the town, lost a case against former Town Councilor, Deb Paul, where the judge concluded a Sexual Harassment complaint against Paul by Malaguti was frivolous, ordered the town to pay Paul's legal fees and provide her with a copy of the complaint.

The court action cost the taxpayers approximately \$15,000.

At last week's Planning Board meeting, members voiced their frustration with what is current state of service in Town Hall.

Town Council liaison, Shawn Farber, mentioned that Malaguti is not currently "actively involved" in operations.

Planning Board Chair, Jake Butler, said that even with Kellie Caron, the assistant Town Manager, back, we're very short. Meaning there are staffing issues in need of being addressed.

Butler said, "The institutional knowledge inside of the Planning

Department is gone. It left two years ago."

Members asked Farber about the state of Malaguti's role in town, to which he responded, "I can't speak to that."

Members also questioned why the Assistant

Town Manager wasn't at the meeting.

Reaching out to Town Council Chair, Chad Franz on who is currently running the town. He responded, "I don't have any update to provide at this time."

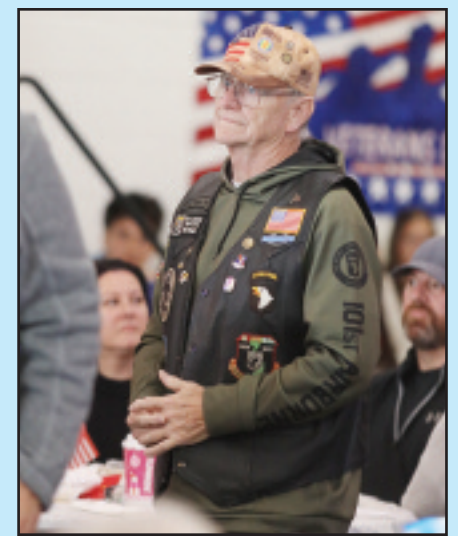
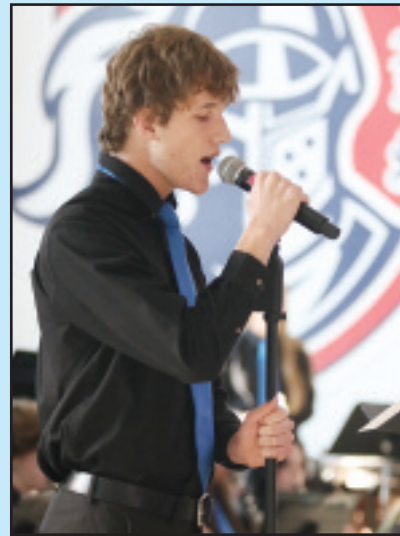

HB1569 Effective Nov. 11, 2024

To the editor,

On behalf of the supervisors of the checklist here in Londonderry, I would like to make our

citizens aware of a change in our voting law that went into effect on Nov. 11, 2024.

Moving forward, potential voters must bring proof of citizenship, age, identity and domicile with them when registering to vote. Previously, without proof of one or more of those qualifications, potential voters could sign a legal affidavit swearing and affirming to the information. Additionally, before Nov. 11, 2024, if you forgot your ID, there was an opportunity at the polls to get your picture taken and sign an affidavit. That exception is also gone and failure to bring an acceptable photo ID will result in you being turned away at the polls.

The law is HB 1569 – Laws of 2024, Chapter 378 -Relative to Eliminating Voter Identification Exceptions. The law no longer authorizes an applicant when registering to vote to complete affidavits as an alternative means of proving their qualifications as a voter. If an applicant does not provide acceptable documentary proof of identity, age, U.S. citizenship, and/or domicile, they are not eligible to be registered to vote.

You can vote in local, state and Federal elections in NH if you are:

- A U.S. citizen
- At least 18 years old on election day
- A NH resident

(Your primary residence, domicile, is in NH). If you have recently moved to NH, you can register as soon as you establish your primary residence here.

Here are some examples of documents that applicants for voter registration can bring to the town clerk's office or to the supervisors of the checklist when they wish to Register to vote. A complete list of acceptable forms of ID, citizenship and domicile can be found here: www.sos.nh.gov/elections/register-vote

and you do not have the proper documents, we will have to request that you go retrieve the documents and return to register to vote.

We desire that all eligible voters can register and vote in NH so please bring all your required documents when registering to vote.

TOWN OF LONDONDERRY LEGAL NOTICE

The Department of Public Works would like to remind residents of the snow ordinance regarding parking and the placement of snow on the streets. The **Winter Parking Ban** is in effect from Nov. 1 to April 1. During that time, no person shall park any motor vehicle on any public road or right-of-way between 12 a.m. (midnight) and 8 a.m. or at any other time as to impede snow removal operations. Any vehicle parked in violation of this ordinance will be towed by the Police Department. Any vehicles so towed will be stored and released to the owner only upon payment of the cost of towing. No person is allowed to place any snow or ice upon the surface of the traveled portion of any Town maintained portion of road or highway. Blowing, shoveling, or plowing snow into the street, creates a very dangerous situation that can cause swerving and accidents. Any person violating this ordinance may be subject to a penalty as specified in the Town's Snow Ordinance.

Generally, the Town has a 50-foot right-of-way, which extends 13 feet from the edge of pavement. Residents are asked not to reconstruct road shoulders and swales or place any structures and landscape items within the Town Right-of-Way. Stakes, delineators or rocks create a road hazard and should be removed. The Town is not liable for damages that may occur to objects placed within its right-of-way.

Mail and newspaper boxes are allowed in the Town's right-of-way. To reduce the possibility of damage, mailboxes should be installed in such a manner that no part of the mailbox is within three feet of the edge of pavement. Installations should be sufficiently sturdy to withstand the weight of heavy snow resulting from plowing operations.

Trash barrels & recycling barrels should not be placed in the road where they can impede traffic or snow removal operations. Place trash and recycle barrels in your driveway or in an area cleared outside of the travel lane.
