Town Manager Responds to Resignation of Fire Chief

n response to the resignation of London-Butler, during the Monday night Oct. 7, Town Council meeting, Town Manager, Mike Malaguti, released the following retort.

Malaguti said, "Chad Franz and I learned of the Fire Chief's intention to resign entirely from the fire service ten hours before last night's Town Council meeting. While the details of that conversation are private, it is important to note that we asked the Chief to reconsider, and for more time. When he indicated his mind was made up, I asked the

time member of LFD in some capacity."

He added, "The Chief derry Fire Chief, Bo shared his love and support for us, and we did the same for him. I made no attempt to discourage the Chief from saving his piece last night in a way that was true to himself, as I have always done with all town employees."

> In reference to the allogations made at the meeting Malaguti said, "The picture presented last night by the multiple speakers following the Chief's departure is yet the latest, inaccurate portrayal of what is going on in the town departments, this time featuring a new low: the

\$18,000 for station maintenance, \$12,000 for the safety program, and \$126,497 for overtime. In my first three years in office, I have proposed and the Town Council has approved \$524,798 in budgetary increases for LFD, an increase of 6.5%. When this year's Article #15 proposing \$495,000 to hire additional firefighters is included, the budgetary increases the Town Council and I have supported rises to \$1,019,798, or 12.7%.

I am also proud that over the past three years, the Town Council and I have supported other significant LFD requests, including:

• \$709,969 in contract increases, which were ratified by the voters in 2022;

• \$495,000 in funding (year 1 expense) for additional firefighters to staff each battalion at 13, which the voters approved in March;

• \$120,000 in funding to equip each riding position with an infrared camera;

• \$146,135 in funding to purchase 4 mechanical lifts to move patients in and out of ambulances;

• \$44,360 in funding to purchase an additional command car in order to ensure there is a backup when one is out of service;

• The addition of a second deputy fire chief; • The creation of the

assistant fire chief position;

> • Funding firefighters to obtain paramedic schooling and credentials.

• \$173,293.88 in funding to equip each vehicle with a "minimum load out" of gear and equipment; and

• \$275,000 in funding for the fire equipment and vehicle purchase capital reserve accounts.

In sum, the residents of Londonderry should know that contrary to what was portrayed last night, the Town Council and I have supported more than \$5 million in new funding for the Fire Department since I took office in February 2022an average of \$163,734 per month.

My staff and I have also worked closely with the Fire Chief to fill staffing vacancies. In the three years I have served as Town Manager, we have hired 22 firefighters. It took six years and two months to hire the 22 firefighters before that, meaning we have more than doubled the pace of hiring since I took office. While LFD has been plagued by unfilled positions for years, the Town Council and I have supported filling each vacancy and we have retained these new employees. Our support for LFD does not end with funding decisions. The Town Council, my staff, and I have been proud to attend fire academy graduations, pinning and promotion year in a row because of

and other important events that recognize the exceptional men and women of the Londonderry Fire Department.

The Town Council and I will remain committed to supporting our Fire Chief, command staff, and the members of 3160, and I will continue to do my job managing the Fire Chief and his town department. To clear up two inaccuracies that were posted by Local 3160 on social media, and alluded to last night, neither the Finance Director nor I have "mandated that Chief Butler reduce staff from 13 to 11 members per shift." Instead, we informed the Chief that his overtime budget is trending \$200,000 over budget just one quarter into the fiscal year, and we answered the Chief's questions about possible strategies to address this trend. Similarly, the Chief was not "threatened ... with disciplinary action if he does not comply." This assertion is entirely made up.

Editorial "Smoke Alarms: Make them Work for You"

Oct. 6-12 is Fire Prevention Week this years' theme is "Smoke alarms: Make them work for you"

The latest "Smoke Alarms in the US." report, said working smoke alarms reduce the risk of dying in a home fire by 60%, while the majority of civilian home fire deaths continues to occur in homes with no smoke alarms or no working alarms, according to the US Consumer Product Safety Commission (CPSC) survey.

Smoke alarms can make a life-saving difference in a home fire, but they have to be working in order to protect people," said Lorraine Carli, vice president of Outreach and Advocacy at NFPA. "This year's Fire Prevention Week campaign drives home just how important it is to install, test, and maintain smoke alarms to ensure they're working properly."

The survey also showed that many households have inaccurate perceptions about the age, functionality, and maintenance requirements of their smoke alarms. Nearly one in five households believed all alarms would be working but had at least one functionality issue when tested, including dead batteries. Additionally, only half of households were always accurate about the age of their alarms.

"People tend to be overconfident about their risk to fire, which often leads to a sense of complacency that compromises safety," said Carli. "This vear's Fire Prevention Week campaign works to better educate people about their true risk to fire and the steps needed to make sure they're adequately protected in the event of one.'

Essential fire safety messages for this year's Fire Prevention Week theme, "Smoke alarms: Make them work for you!" include the following:

• Install smoke alarms in every bedroom, outside each separate sleeping area (like a hallway), and on each level (including the basement) of the home.

• Make sure smoke alarms meet the needs of all family members, including those with sensory or physical disabilities.

• Test smoke alarms at least once a month by pushing the test button.

• Replace all smoke alarms when they are 10 years old or don't respond when tested. To learn more about Fire Prevention Week and this year's theme, visit fpw.org. Additional Fire Prevention Week resources for children, caregivers, and educators can be found at sparky.org and sparkyschoolhouse.org.

For more than 100 years, Fire Prevention Week, the longest-running US public health observance on record, has worked to educate people about the risk of home fires and ways to minimize them. Local fire departments, schools, and community organizations play a key role in bringing Fire Prevention Week to life in their communities each year and spreading basic but critical fire safety messages.

Take the time to check your alarms to be safe.

Double Standard by Town Council

To the editor,

Our most recent council meeting on Monday, Oct. 7, left many in our community feeling shocked and deeply dismayed. The unexpected resignation of Fire Chief Bo Butler has resonated powerfully, especially given Chief Butler's heartfelt words about his love for our community and his dedication to his principles.

When a respected and devoted leader like Fire Chief Bo Butler steps down, the impact is profound. His departure creates a sense of loss and uncertainty, as he was a trusted figure of safety, service, and stability. His resignation prompts reflection on the dedication he brought to his role and the integrity he stood for, values the community will undoubtedly want to uphold.

During the meeting, Councilor John Farrell expressed visible frustration and surprise, only learning of the situation five hours before the meeting, leaving him, as he said, without time to "fix it." Former councilman Jim Butler also spoke during public comments, referring to the "Laura Gandia situation" and asking if the council was aware of personnel concerns involving the town's department managers, to which council members replied they were not.

Reflecting on Jan. 23,

2023, the "Laura Gandia

that had not been previously discussed. At that time, the council upheld that per the Town Charter, section 4.8, they do not interfere with town administration. Both Mr. Butler and Mr. Franz supported this stance, with Mr. Farrell reiterating that personnel decisions lie solely with the Town Manager.

> This raises pressing questions about Londonderry's leadership. If Mr. Farrell now expresses regret for not having time to address a personnel matter, how could he do so while adhering to the council's stance? If council members like Mr. Butler urge action on staffing issues, why then dismiss it as outside the council's purview, as was the answer back in January 2023?

Over the last two years, town employees have written to the council describing a workplace marred by bullying, intimidation, and harassment - vet no action has been taken. Monday's disclosure of the council's stance to "just wait two weeks and it will blow over" reflects poor leadership. Ignoring issues has led to valuable leaders resigning on principle, a work culture of fear, and taxpayers bearing the costs of legal fees and being serviced by employees who have lost all trust and productivity

Continued from page 1 for someone that doesn't understand the fire service to truly realize how important these people behind me are to me and I'm not going to be the chief to violate my own character, and my own integrity, and my own principle to come under budget at the cost of their health and safety first and foremost," Butler said. "And any chief that thinks otherwise needs to realign his priorities."

He added: "So I am providing you my resignation tonight as chief of the Londonderry Fire Department."

No decision was made by the Town Council during the meeting to accept the resignation or not.

During Butler's speech, he asked the rank in file, to maintain its composure.

"The community will rise to the occasion but it takes this sacrifice to get there, it will, I know my hometown you will



get the money you need to carry out your mission to be safe so you can provide the service to the people that are counting on you, and then give you every tool you can to get back home to your loved ones in one piece," Butler said.

Town Manager, Mike Malaguti, in a statement to the Londonderry Times. wrote "Chad Franz and I learned of the Fire Chief's intention to resign entirely from the fire service, ten hours before last night's Town Council meeting."

"While the details of that conversation are private, it is important to note that we asked the Chief to reconsider, and for more time. When he indicated his mind was made up, I asked the Chief to remain a fulltime member of LFD in some capacity," Malaguti wrote. "The Chief shared his love and support for us, and we did the same for him. I made no attempt to discourage the Chief from saying his

In a Facebook post morning, Tuesday Christopher A. Schofield. the President of Local 3160, which represents the Fire Department's rank in file wrote "This past March, the citizens of Londonderry overwhelmingly supported Warrant Article 15. which called for the addition of four firefighters, ensuring that each shift would be staffed with 13 personnel. This decision, made by the community, prioritized public safety and provided our firefighters with the necessary resources to protect the town effectively."

"However, town leadership has chosen not to follow the wishes of the community. Instead. they have unfairly placed blame on Chief Bo Butler for circumstances outside of his control," Schofield wrote. "The Town Manager has now mandated that Chief Butler reduce staff from 13 to 11 members per shift, despite the clear directive from the voters. They have of the community's safe-

disciplinary action if he does not comply."

Schofield also wrote about Butler's character saying "Chief Butler, a man of deep principles and unwavering integrity, refused to compromise the safety of our citizens or go against the will of the community. Last night, he made the difficult decision to resign from his position. His resignation is a tremendous loss for our department and town, but it is a testament to his dedication to doing what is right for the people of Londonderry."

"This is not the first time that town leadership has disregarded the well-being of our citizens and employees. Last year, Town Manager Malaguti and Finance Director Campo instituted a town wide budget freeze, which led to a reduction in services, including the closure of the Central Engine Company," Schofield wrote. "Despite these cuts, the town ended the fiscal year with a budget surplus of nearly \$600,000, which will likely be deposited into the undesignated fund balance. This surplus was achieved at the expense

Schofield ended his letter by saying, "We call on town leadership to respect the wishes of the people of Londonderry and honor the staffing levels that were approved by the voters. Public safety must not be compromised for financial maneuvering, and our firefighters should not be forced to work under conditions that put them and the community at greater risk."

"We ask for your continued support as we advocate for the safety and well-being of Londonderry and its first responders," Schofield wrote.

Battalion Chief, Bruce Bruce Hallowell, spoke during the meeting, telling the emotional story of almost dying during a call two years ago. He said the person who saved him was Butler.

We were 30 seconds in this community away from a line of duty death. That's what we're talking about. And the man that just left here he saved my life," he said.

Hallowell said he also hoped there would be a way for him to return.

"So I ask, I beg, please restore the ability for our leader to return to his post," he said.

Dan Bouchard, a former Londonderry police officer, said he saw Butler grow up, and said unlike some past depart-

ment heads, the fire department supports Butler.

"We wanted the 13 on staff, I'm an elderly person, I have a community that has a lot of elderly people, we have a lot of elderly people in the community," Bouchard said.

Bouchard also urged the Town Council to think about the decision taking place.

"I don't know what happened here, but it's not good to lose Bo Butler as the chief, and please don't let him walk away," Bouchard said.

Former Town Councilor, and the father of Bo, Jim Butler, spoke during the meeting, raising concerns, including a letter Bo received from Town Manager, Mike Malaguti, about a five day suspension without pay.

"I saw a letter from my son, who's never had a problem, people have said he's done great things, he's got great reviews, I saw a letter from your Town Manager that said he was going to get suspended for five days without pay," Butler said.

The Londonderry Times has not received a copy of the letter mentioned.

"I'll tell you something, you have a management problem here, look into it," Butler said.
