Pinkerton Academy Moves to Remote Learning, Cancels Sports

Last week, Pinkerton Academy Headmaster, Dr. Timothy Powers, announced that, because of people that are a part of the Pinkerton community tested positive for COVID-19 and attended school after knowing that, officials at the school have decided to stop the hybrid model of learning and switch back to remote learning for the remainder of the month. The fall sports program at the school was also cancelled.

In a statement released on Wednesday, Oct. 14 Powers said the following:

"Today we were notified that another person in our daily school community has tested positive for

COVID-19. This individual was last on campus on Thursday, Oct. 8. Unfortunately another individual who had knowingly been exposed to this individual came to campus today despite being told to quarantine. Additionally we are aware of significant community exposure linked to these cases due to activity outside of our daily operations. We have learned that these cases all stem from a common exposure from a few remote community members who did not follow quarantine guidelines.

"Now the impact is being felt across our daily campus community as

"As a whole, our community has worked hard to precautionary follow measures and protocols to keep our campus healthy. This has meant making many sacrifices in the interest of the good of the larger community. "Unfortunately, the decisions of a few have impacted us all negatively, and we are now forced with the need to change our current daily operations. This community exposure has led to a significant number of staff and students who may have been exposed and will possibly need to quarantine. We cannot remain open in the hybrid model with this percentage of our continued on page 2

Community Caregivers of Greater Derry & The Loaner's Closet for Durable Medical Equipment has moved back to Derry after spending the past six years in Londonderry.

The Caregivers last location in Derry was in the Masonic Temple, but space needs had them move to Londonderry. The new Derry location is right in the heart of downtown,

accessible to all and open back to the public after seven months of only being able to provide curbside services.

The new location, in the historic Merchant Row Depot Square Office Building's basement floor, is complete with 4,100 square feet of office space, meeting spaces and Loaner's Closet showroom.

On Sunday, Oct. 18, another announcement was sent out to the community.

'Today we were notified that another person in our daily school community has tested positive for COVID-19. Because we have been in remote learning, the New Hampshire Department of Health and Human Services (NH DHHS) has determined that no exposure to our daily campus community occurred on campus. Derry Town Council Goes Over Halloween, Town Revenue and More

The Derry Town Council met on Tuesday, Oct. 6, for a quick-paced meeting that hit on several different topics pertaining to the town's recent and upcoming events.

Chairman Charles foot made two nominations for new committee members, but only one passed. Mark McClary received unanimous approval to join the Economic Development Advisory Committee. His term will run through the end of March 2021. His other nomination, however, ended up in a 3-3 stalemate that will be revisited at their next meeting. For now though, Lorraine Lindenberg's potential spot on the Cable Advisory Committee remains up in the air. Councilpeople James Morgan, Richard Tripp and Phyllis Katsakiores all voted no, while Councilman Joshua Bourdon, Councilman Brian Chirichiello and Foote voted yes. No explanation was offered for the lack of approval.

DERRY - The Derry Economic Development Advisory Committee held its first meeting since March on Oct. 5, to discuss the future plans of the committee.

The future of the Economic Development Advisory Committee is uncertain due not only to the needs of the community but the attendance from committee members and open positions on the EDAC.

The EDAC was formed before there was an Economic Development Director position and were in charge of handling the outreach to small businesses, social media, and business education for business owners in the town of Derry. Since the town created an Economic Development Director and the pandemic this has left the EDAC to question their purpose and/or goals. The committee came to the agreement that they would wait and take direction from the Town Council to decide on any further plans for committee meetings and tentatively schedule a meeting six months out pending instruction from the Town Council.

Due to the member vacancies the EDAC was not able to hold an official forum the night of the meeting, but was still informed on the new ongoings of businesses in town since they last met.

Editorial **As Election Day Nears**

Election Day is Tuesday, Nov. 3, and we have the opportunity to vote for state, county and federal officials. Those elected will be asked to make vitally important decisions that in many cases affect our daily lives

Out-of-state money is flooding our mailboxes with fliers touting candidates. Television ads range from bad to worse, and lies and misrepresentations and out of-context comments lead the way.

As it gets closer to Election Day, the ugliness can be expected to get worse, although making negative comments about a candidate's is just in bad taste. Stick to the facts and platforms'.

It's hard for the average voter to fight his or her way through what's just not true and what is way out of context. Meanwhile, many candidates deliberately choose to speak in generalities rather than with facts. Which candidate is going to be in favor of raising taxes? It's safe to say every one wants taxes lowered.

But if you ask for details on how less government and lower taxes will be accomplished, and at what cost to specific services, few are willing to suggest the answer - or acknowledge that one person alone cannot effect broad-based change.

We remind you that every candi-

date is going to smile broadly, shake as many hands as possible, promise wonderful things. Their family members will say how near-perfect they are. Should that persuade us? Don't get sidetracked by the packaging.

So even if you've already made up your mind, consider your choice again, weighed against the competition. How would voting the party line benefit you? What about a candidate's willingness or ability to work with people of all political persuasions - i.e., working across the aisle. If we had that in Congress, we'd be far more likely to have a functioning government.

Your vote counts, but it means so much more if you cast it after making a studied, educated decision, not one based on inflammatory rhetoric or physical appearance or a bright smile or a party label. All those will become nothing more substantial than a fading memory after the election.

Holding public office is a vital part of our democracy. No one is entitled to it. Public officials should have to earn our trust and respect before they get our vote. Think about that as Election Day approaches and you decide on your choices. And please, don't miss this opportunity to vote.

continued from page 1 agency has hundreds of seniors and disabled individuals dependent on them so interruption of service was not an option." said Executive Director Cindee Tanuma.

The Caregivers prayers were answered with more angels than they can count. An online giving campaign yielded nearly \$8,000 to pay for renovations and a grassroots paper campaign raised twice that much.

All the donors wanted to be part of the 32-year-old story that is Caregivers.

Benson's Hardware provided all the lumber and sheetrock, the Derry Village Rotary provided the labor to design, frame and construct the new offices which were formally an open concept daycare.

The Londonderry Rotary underwrote the cost of carpet and vinyl cleaning, Sherwin Williams and Steve Dente of Simpson Painting provided paint and supplies, Jackson Lumber donated all of the doors, Alpha Locksmith assisted with rekeying the facility, Valley Networks installed all data lines and security cameras, ServPro for VCT removal, New England Royal for postconstruction cleaning. Harry Carter Master Electrician & Nusbaum Electric completed all electrical work, ReSource Office Furniture in Salem provided office furniture and some carpeting, People's United Bank donated additional office furniture and Ed's Flooring and SNH Plumbing for completing their work in a very short time frame and Rig A Tony's provided food for the workers for one whole week . Close to 40 volunteers helped with construction, plumbing, painting,

cleaning, packing and moving and unpacking donating a cumulative 500 hours of service.





When you go see an attorney you want answers. Whatever confronts you, only straight answers will help.

Unfortunately, some in the legal system tend to use language as a shield against real communication.

One barrier is Latin. While fewer and fewer Latin terms are actually used today, some Latin finds itself deeply rooted in the law even now.

Here are some top Latin terms persisting in the language:

Ab Initio: Means "from the beginning". If a court says a contract is void "ab initio" they reject the entire agreement. Don't even argue about certain provisions or the way the parties acted as if they had an agreement. Rewind the legal history and start over.

Letters

a higher court will review a lower court ruling. Commonly used in the term 'Writ of Certiorari'. This is a request filed with the U.S. Supreme Court asking the highest court in the U.S. to overturn a lower court ruling. Of course the U.S. Supreme Court can either accept the appeal or not.

Codicil: A codicil to a will amends the original will. You can't just write notes on the will or on a separate piece of paper. To effectively change anything in a will, the amendment must comply with the same formalities as the original will. That means witnesses and a notary. The document amending the will is called a codicil.
