

Chester Selectmen Approve Road Agent Warrant Article

CHESTER - During the Feb. 3 Chester Board of Selectmen meeting members heard from the Public Ways Working Group.

The group was tasked by the Selectmen in December to look at the possibility of changing from an elected Road Agent to a full-time employee.

It was pointed out by Myette that there has been discussion since 2004 about moving away from an elected position to a full-time employee.

However, he said that this is the first time there has been a group formed to look at it in depth.

One question that was raised was what kind of contract they should expect to give the person as far as the number of years.

The new budget totaled \$4,924,225, an increase from last year's budget of \$4,709,135. This sum would have an estimated cost of \$7.23 per thousand.

In all 14 warrants were discussed, with the majority of them not inspiring questioning.

Two warrants concerning funds for the road improvement proceed without much discussion. These funds totalled \$162,044 for road The town is currently improvement programs and \$547,500 for the Road

Another warrant raised Capital Reserve Fund. According to Selectman Tombarello money would go to a fund that will be matched 20/80 from the State for bridge repairs that are scheduled for 2027.

Tombarello said if the money isn't put into the fund there will be jersey barriers set up around Phillips Road bridge and possible others. Tombarrello warns that these barriers may slow down emergency vehicles.

'This really needs to be done," said Tombarello.

Another discussed warrant would add an additional firefighter and/or EMT, for the cost of Capital \$54,000. Vice Chairman,

DERRY - During the Feb.1 Derry Town Council meeting one of the agenda items was in regards to the public safety facility needs.

Derry Town Administrator Dave Caron explained that in April they formed a Subcommittee including staff, and Town Councilors Charlie Foote, Joshua Bourdon, and Erin Spencer, who were tasked with evaluating the conditions of the public safety facilities and to evaluate response times.

In June they made a presentation but the Council decided that they needed more precise informa-

CHESTER - On Tues- & Breakfasts. day, March 8, polls for Warrant Articles 1 through 7 will be open from 7 a.m. to 7 p.m. After the ballots are counted, the Meeting will continue on Thursday, March 10, at 6 p.m., in the Multipurpose Chester Room. Articles 8 through 27 will be taken up at that time.

Article 1: To choose all necessary Town Officials.

Article 2: Are you in favor of the adoption of Amendment 1 to the Town's Zoning Ordinance as proposed by the Planning Board?

Amend: Article 2 - Definitions - Impervious Surfaces

Purpose: To add a clarifying definition of "Impervious Surfaces" as referenced in Table 1.

Article 3: Are you in favor of the adoption of Amendment 2 to the Town's Zoning Ordinance as proposed by the Planning Board?

Amend: Article 2 - Definitions - Sign Types

Purpose: To amend the definitions of various sign

The term of the elected road agent will terminate at the 2023 Annual Town election. Further to raise and appropriate the sum of \$55,417 salary and

Article #11 - Renaming of 300th Anniversary Fund

Shall the Town rename the 300th Anniversary Celebration Capital Reserve Fund to the Significant Anniversaries Capital Reserve Fund in order to continue accruing funds for significant anfuture niversaries. 2/3rds ballot vote required.

Article 12 -**Discontinuance of Hart Roberts Road**

Shall the Town discontinue as an open highway under RSA 231:45 the following highway: Hart Roberts Road from the intersection of Hart Roberts Road and Halls Village Road to the

Road and Jack Road (the entire road). This discontinuance will take effect June 1, 2022.

Article 13 - Operating Budget

Selectmen recommend \$5,531,657. This article does not include appropriations voted in other warrant

Article 14 - Establish **Culverts and Crossings Capital Reserve Fund**

Shall the Town establish Culverts and Crossings Capital Reserve Fund under the provisions of RSA 35:1 II for the purpose of funding the replacement of road culverts and crossings in the Town of Chester, and to raise and appropriate the sum of \$50,000 to be placed in this fund. Further to authorize the transfer of \$50,000 from the June 30, 2022 unassigned fund balance for this purpose with no amount to be raised from taxation and further to name the Board of Selectmen as agents to expend from this fund.

Article 15 - CIP Funding

Shall the Town raise and appropriate the sum of \$600,000 to be added to the capital reserve fund known as the Town's Municipal Capital Improvement Plan Capital Reserve Fund established at the 2013 Town Meeting.

Article 16 - CIP Projects

Shall the Town raise and appropriate the sum of \$791,250 for the following projects:

Article 18 - Highway CIP **Projects**

Special Warrant Article. Shall the Town raise and appropriate the sum of \$1,251,734 for roadwork in the Town of Chester and withdraw \$551,734 from the funds received from the American Rescue Plan Act of 2021 and the remaining \$700,000 from the Highway Capital Improvement Plan Capital Reserve Fund created for these purposes.

Article 19 - Funding of **Culverts & Crossings CRF**

Special Warrant Article. Shall the Town raise and appropriate the sum of \$4,885 to be added to the Culverts & Crossings Capital Reserve Fund previously established. This which represents accrued interest in the Winter Road Maintenance Expendable Trust Fund which causes it

Further to authorize the transfer of \$250,000 from the June 30, 2022 unassigned fund balance for this purpose with no amount to be raised from taxation.

Article 22 - PACT

Special Warrant Article. Shall the Town raise and appropriate the sum of \$38,000 for the purpose of providing public, educational, and governmental access television in the Town of Chester. Said funds to be withdrawn from the Special Revenue Fund known as the "PACT" Fund established at the 2003 Town Meeting, separate from the General Fund and funded by Com-


She enjoyed meeting and helping people. She was honored in being named a Melvin Jones Fellow by the Lafayette Lions Club and served as King Lion of the Club.

It is the shortest month of the year. The month is named for the Latin word februum; meaning purification, together with January. It was the last of the months added to the Roman calendar.

would any other Town employee where they would be placed on a probationary period and if it works out they would continue.

Oleson told the Board of Selectmen that he was in favor of moving to a fulltime employee.

"I am 100 percent behind eliminating the elected Road Agent position," said Oleson.

He said that every two years you never know what can happen with elections and that they need to move having an actual employee.

"It's time we're growing," he said, noting that other towns have or are going to be doing the same thing.

Selectmen Stephen that he Landau said

they should let the voters decide.

Landau pointed out that under the RSA they are only allowed to put this type of warrant article on the ballot when there isn't an election for the Road Agent position in the same year. It means that if they don't put it on the ballot or it doesn't pass it won't appear again for at least another two years.

It was explained during the meeting that aside from discontinuing the elected Road Agent position next year the warrant article will ask voters to approve raising \$55,417. Myette said that it will allow the new road supervisor to work with the Road Agent for three months until March and then can continue to work on their own until

Jonathan Goldman said there is currently 40 hours of coverage for this role and the proposal would raise that to 100 hours. This would be equal to 2 people per day with 10 hours per day.

Among the warrants were three that allocated funds for expendable trusts. One was the Phillips Pond Expendable Trust with \$500 for the purpose of protecting the pond. Another was for the Plowing Expendable Trust and totaled \$50,000 while the last was for the Celebration Expendable Trust and came in at \$8,000.

There was \$28,245 to control exotic aquatic species including variable milfoil and fanwort in Phillips Pond.

Lastly there were warrants for the Revaluation Capital Reserve Fund (\$10,000), Stormwater Management Capital Reserve Fund(\$10,000), Fire Equipment and Apparatus Capital Reserve Fund(\$50,000), Government Building Capital Reserve Fund(\$7,500) and Fireworks(\$4,500).

The session lasted only about an hour and was attended by about 20 community members.

The votes were only discussed at the meeting and the actual vote will occur on March 8 at the Town Hall. There citizens will also have a chance to vote on warrants 2-15 and warrant one, (the choosing of town officers.)

The 2022-2023 School District operating budget warrant article was discussed at some length and it will ask voters to approve raising and appropriating \$94,252,087 for the school district.

As part of the committee, Caron said that they were able to outline the different options including for a new substation and the cost for a new public safety facility.

Caron said that under the current conditions a substation would cost about \$6.8 million.

He said that a public safety facility would likely be in the \$40 million range.

"It's a really expensive undertaking," said Caron.

Caron explained that the Alexander Carr property is part of a larger lot and they want to look at a piece of land there adjacent to the drug store on Rockingham Road to place a potential substa-

He said that they would return to the next Council meeting with a resolution asking for a transfer of up to \$10,000

from the Fire Capital Reserve Fund to have a design team look at the site and see if they could place a structure on the site and to see if it would be a safe place to put the station. Caron said if it is feasible they would then look at where the line is for what needs to be used as recreational space and what can be used for the substation.

Either way Caon said that the skate park wouldn't be impacted at all.

Town Councilor Neil Whetherbee asked what the response time would be if they placed a substation in Southwest Derry.

Interim Fire Chief Jim Richardson said that if they placed the substation in that area it would reduce their response

"It will definitely get the rest of west Derry in the four to eight minute response time which we are looking for," said Richardson.

Caron also explained that because the projected cost of a public safety

complex would be so much he doesn't think they would be able to build it without going over the tax cap.

Town Council Chairman Jim Morgan said that he thinks a better solution would be to run five substations for now. He said that way if the school district decides to pursue building a new school, taxpayers wouldn't have to pay for both at the same time.

"None of us want to vote to go over the tax cap," said Morgan.

Caron said that he thinks the first step is to build a substation in Southwest Derry address their response times, and if they are able to rebound with their revenues over the next few years they may be able to build a public safety complex while staying within the tax gap.

He said that they wouldn't need any more staff for the fifth substation, noting that they would move extra staff from the Central Station to fill in there.

Whetherbee said he thinks they should move forward with looking at the substation more.

Caron said in addition to looking at the substation they can have the designers look at making a plan for the public safety facility, and a fire headquarters.

Morgan said he is supportive of looking at a new substation, just a new Central Station or a Public Safety Complex.

Caron pointed out that they currently don't have many bonds on the books, but it means that they can't rely on bonds coming off the books in order to relieve the tax burden.

Town Councilor Brian Churchillo said it would also be important to know what the schools plan is moving forward so they can fit it in the plan as






