Council Okays Restricting Parking on East Broadway

DERRY – During the Tuesday, Nov. 2, Derry Town Council meeting one of the agenda items was in regards to amending a traffic ordinance.

It was explained by Scott Savard, the Highway Safety Committee Chairman that they have had an influx of people parking along East Broadway near 94 East Broadway, which has caused safety issues for pedestrians and for oncoming traffic. Their recommendation was to prohibit parking along the south side of East Broadway

from Park Avenue to the traffic circle, and from the traffic circle on the north side of Broadway to Marlboro Road.

It was explained that the fiscal impact for the town of Derry to go forward with the new restrictions would be \$2,300 for the no parking signs and post. This wouldn't include their staff time.

Savard said there would be a provision in the ordinance that states that the no parking could be waived for Town sponsored events especially at MacGregor Park.

The Council ultimately approved the ordinance.

Council member Joshua Bourdon voted against the ordinance saying that he thought they could explore other options.

"I think voting this in lacks creativity and there is a way to achieve parking and make it safer," Bourdon said.

Also during the meeting the Council voted on an ordinance to prohibit parking on Franklin Street.

It was explained by Savard that a resident asked that the issue be brought up by the Highway Safety Committee and they did during their Aug. 19 meeting, and

Hampstead School Board Votes No on Special Meeting

HAMPSTEAD – The Hampstead School Board discussed what they would do in regards to a petition that they received calling for the District to have a special meeting during their Oct. 26 School Board meeting.

At their previous meeting Superintendent Robert Thompson told the School Board that if they went forward with the special meeting the questions the petitioners want on the ballot is "To see if the voters of the Hampstead School District will vote to adopt the following provisions pertaining to requirements to wear face coverings within the Hampstead

School District:

The use of face coverings shall be optional for all students at the sole discretion of their parent or guardian. The use of face coverings shall be optional for any employees and visitors on school district facilities and attending school sanctioned events."

During the meeting Thompson also told the School Board what the RSA states regarding special meetings.

"A special meeting of a school district shall be held whenever, in the opinion of the school board, there is occasion therefor, or whenever 50 or more voters, or 1/4 of the voters of the district, whichever is less, shall have made written application to the school

board therefor, setting forth the subject matter upon which action is desired," it states. "No special school district meeting shall be held in conjunction with the biennial election, except when a special school district meeting has been approved by the court and a school district has adopted the official ballot referendum form of meeting pursuant to RSA 40:14."

Hampstead School Board Chairman David Smith explained that they asked their attorney for an opinion on the direction they should go. Smith said that while it was ultimately their decision, their legal counsel said that the School Board is the gov-

Sandown Selectmen Set Tax Rate, Reject Special Meeting

SANDOWN – During the Nov. 1 Sandown Selectmen meeting, the set the town's tax rate at \$28.98.

Blaisdell explained that they got the preliminary tax rate back from the State which would be \$29.27 per thousand.

She explained that depending on how much they use from the unassigned fund balance they are able to reduce it by a few cents.

She said that the lowest it could be is \$28.73 per thousand if they allocated \$330,000 from the fund balance for it.

Blaisdell said that they have been working on try-

ing to keep more in the fund balance since they don't have a strong enough fund for emergency situations.

After some discussion about how much they would use from the fund balance the Board of Selectmen ultimately approved the tax rate at \$28.98 per thousand. They

Sandown Planning Board Gets Updated on Dackam Fields

SANDOWN - During the last month's Sandown Planning Board meeting the Board had a hearing regarding a conditional use permit application and consolidation and subdivision application for the property located at the Northern end of Diane Lane.

Representing David Hoyt, the owner of the property was Charlie Zilch.

Their plan is to subdivide 34 acres of land on the

property which is known as Dackam Fields.

Zilch explained that he had received comments back from Alteration of Terrain and other state agencies and had begun to review and change his plan sets.

Zilch told the Board that there had been no substantial changes requested by the State.

During the meeting Zilch also told the Board that he plans on creating an easement for the two access points into the backlot. Steve Keach, the Engi-

neer for Sandown said that by having an easement it will benefit both the Town and the developer, if he chooses to continue to build on that property.

It was pointed out by Zilch that despite removing those two access points from the open space calculation they will still meet the open space requirements.

"It does meet your open space requirement," he said.

During the meeting Keach also laid out some suggestions for things they

may want to look at in their possible conditional approval.

One thing that was pointed out by Keach is that they should ask for a fair share contribution that is similar to the one they asked for in the Hoytford Hills conditional approval. He explained that the money would go towards the repaving of Ferguson Lane which they hope to be able to do in 2022 when the second portion of Odell Road gets repaved.

It was pointed out by Zilch that he hadn't met

with the Conservation Commission at the time of the meeting to get their approval for the conditional use permit. He said that he would be meeting with the Commission on Oct. 28 with the hope of gaining favorable approval from them.

He also noted that he is planning to reach out to the Recreation Commission regarding his waiver request.

Zilch asked for the applications to be continued until the Board's Nov. 16 meeting which the

Board approved.

Also during the meeting the Board approved a continuation request for 65 Odell Road to their Nov. 16 meeting. Keach explained that he spoke with James Lavelle, who is representing the owner. Keach said that Lavelle told him that he was able to get plans in place for the driveway which he couldn't get before.

The next Sandown Planning Board meeting is slated to take place on Nov. 16 at 7 p.m.

Derry Zoning Tables Ballard Road Variance Request

DERRY - The Derry Zoning Board held its regularly scheduled meeting on Nov. 4.

During the meeting the Board heard a case regarding the construction of a single family home located at 26.5 Ballard Road. The owners were seeking a variance to build the home there without having enough frontage as required.

It was explained by Timothy Peloquin, who was representing the owners that the property was originally supposed to be used as a community well lot about 40 years ago, and would have supplied the water to the homes in the area.

After it was determined that it was sufficient enough to provide the amount of water needed the well was never built and the lot has remained empty.

Peloquin explained that the Cooper family who own the property are in the process of cleaning up their properties and this was one of those.

One question that was asked was if they are planning on building a home on the property first and then are going to sell it or if they are planning on just selling it as the land.

Peloquin said that they are looking to find a suitable buyer and will either contract someone to

build it or will just sell the land to the buyer.

During the meeting multiple abbutters spoke against the variance being approved.

One of those was Janet Virr who said that she has lived at 20 Ballard Road for the last 36 years.

She brought up that there was a variance request from about 18 years ago for the lack of frontage on Ballard Road which was denied.

She said that aside from not having enough frontage there were also issues with the fact that the Coopers had made promises to

prospective buyers saying that they weren't going to build anything on the lot.

"It should be denied as it was in 2003," Virr said.

John Cooper who was in attendance at the meeting said that at the time they didn't think that they were going to build on the property.

He also noted that they offered to sell it to the neighbors surrounding the property multiple times over the past 10 years without any interest.

One of the main questions that the Board had to consider was whether or not the variance request

would be a repetitive request or not because of the previous ruling.

Chairman Lynn Perkins said that he thought the Board should review the new documents they received during the meeting and then put it back on the agenda for a future meeting.

"That's the direction I think we should go," Perkins said.

The Zoning Board ultimately voted unanimously to table the case.

The next Derry Zoning Board meeting is slated for Nov. 18 at 7 p.m.

Hampstead School Board Hears Budget Presentations

HAMPSTEAD - During the Oct. 26 Hampstead School Board meeting the Board heard from the school district's different departments regarding their proposed FY 2022-2023 budgets.

Superintendent Robert Thompson said that they were presenting the different items that they are intending on including in the proposed budget and didn't include salaries.

"What you see tonight really is a draft," Thompson said.

He said that they want to get feedback from the community and the School Board about the budget, and will have chances

throughout the budget process for community members to give their input.

Thompson said that through their budget one of their goals is to be financial stewards of the community, saying that they want to make sure they are as efficient as possible with their funds.

"We understand that we are asking our taxpayers to make a significant investment in our schools," Thompson said.

He explained that they used a zero budget form of budgeting this year which means they started their budgets from scratch and only budgeted specifically for what they need. Thompson said that usually budgets are done based on

using previous budgets and account for things like inflation.

Central School Principal Terrilyn Cheney said that their proposed budget is \$ 204,415. She said it's a decrease from this year's budget by \$26,255. The current budget is \$230,670.

She said that the biggest decrease for their proposed budget is in the mathematics department which has a proposed decrease of \$53,000. She explained that it was because they invested in "Big Ideas" last year and their three year contract includes workbooks.

Middle School Principal Maria Di Nola said their proposed budget for next year is \$ 204,294. She

said that the current budget for this year is \$ 361,971 which means the proposed budget is \$157,677 less than this year's.

The biggest difference between their proposed budget and the current one is savings for textbooks.

It was explained that they purchased new math and social studies textbooks this year. She said the savings for math textbooks would be \$ 111,650 and \$ 49,040 for social studies textbooks.

Presenting the proposed budget for the facilities department was Director of Facilities Jeff Mackey.

He explained that the proposed budget is \$ 839,478 while the current budget is \$ 2,695,449

which is a decrease of \$1,855,971.

Mackey said that the largest part of the decrease is because \$1.66 million was allocated for the 60s renovations.

Mackey said that they were also able to benefit from the zero based budget process.

"I was really able to dive deep and adjust all my needs to whatever the best fit was for each account line," Mackey said.

One of the other budgets that was discussed during the meeting was for Pinkerton Academy tuition.

It was explained by Director of the 21st Century Learning, Assessment, and Technology Nicole Tomaselli that this year

they currently have 392 students enrolled at Pinkerton Academy and next year they are expecting to have 394 students enrolled there.

It was also explained by Tomaselli that they budgeted for 440 students attending this year for a total of \$5,903,436.

Since they have only 392 students enrolled their projected cost is now \$5,369,616, meaning they may save upwards of \$600,000 this year.

Next year's budget projection is \$5,666,902, which would account for a five percent increase for tuition. Tomaselli said that the tuition increase varies each year but they estimate higher.

Derry Residents Will See a Tax Rate Increased of 1.72%

DERRY - The town of Derry recently announced the establishment of the 2021 Tax Rate to \$24.76. The new rate shows an increase of 1.72% over last year and tax bills are expected to be mailed out shortly with an expected due date of Thursday, Dec. 9, 2021.

The NH Department of

Revenue establishes the rate using four factors: Town services; local school costs; state education; and Rockingham County taxes.

The tax rate change:

According to a press

release by town officials the appropriation for town services funds the police department, fire department, emergency medical services, public works, recreation, public libraries, public health, welfare, planning, code enforcement, the transfer station, water, wastewater, community access television and government administration.

Public Works services

include the purchase, maintenance and replacement of roads, parks, bridges, dams, vehicle, equipment, land, and buildings.

Revenues raised by service fees, permits and grants reduce the amount that is needed to be raised through taxation.

Public water and waste-

water are paid for through user fees.

Community Access Television is funded through Comcast Franchise Fees.

The School District funds support the education of students in preschool to grade eight. These funds support both

general and special needs educational services. Additionally, the district currently pays the tuition for Derry students, grades nine through 12, attending Pinkerton Academy.

With the new rate, a home valued at \$400,000 will pay \$9,904 in taxes.

I love Derry. I love it's small town character and its family-friendly atmosphere. I met Mary Eisner when I first moved to Derry through her work to preserve Derry's rural, climate-friendly environment. Her support for Derry's public schools has always been a priority. When she was in the legislature in 2019-2020, she voted for the Democrat-crafted state budget which awarded nearly \$7,000,000 to the Derry public school system and nearly \$1,000,000 to the town of Derry itself. It is this money that helped to reduce Derry's property tax rate from \$26.12 to \$24.76 per thousand evaluation. None of the Republican Derry Representatives voted for the budget.

erning body which means they can implement things like mask mandates.

Smith said that the legal counsel told them that they have two options. The first one would be to not call a special meeting and the other would be to have the special meeting but make it advisory only.

Smith explained that they would have to spend money on it and it wouldn't be something they would be able to do right away.

He also pointed out that because the COVID-19 vaccine will soon be available for everyone five years old or older that they will likely be taking a vote soon on making masks optional which would

make the issue moot anyways.

While the School Board members said that they appreciated the effort community members made to file a petition, they felt that with the timing of the vaccines becoming available combined with the special meeting being advisory only they voted against having a special meeting.

Wason Pond Commission Discuss Bridges and Dog Beaches

CHESTER - The Wason Pond Recreation and Conservation Area Commission met for their monthly meeting on Monday, Nov. 1 at the Rangeway Meeting Room.

After approving the minutes of the last meeting, Alex Brillhart updated the Commission on his Eagle Scout project. Alex proposed back in Febru-

ary to build a puncheon bridge to replace the old bog bridge that was rotting away.

He came to this meeting to report that the bridge is done. "I spent a while making the plants. Then, I set out and [worked] on the sections of the trail right there," said Brillhart. "I went back to my house and made all the concrete [blocks] that go under the bridge. I had 15 of those

and they were about 11 feet tall."

Brillhart then made 11-foot x 4-foot-wide sections out of tamarack wood that went on top of the concrete blocks. Commission members expressed their gratitude and were pleased with how the bridge came out.

The bridge was not safe to walk on with it rotting and it could have fallen a part any minute. The new bridge that

Brillhart put in place of it is much safer and was built in a way so that it will last for many years to come.

After Brillhart's presentation, the Commission moved onto the dog leash ordinance that was discussed in the Selectman meeting from Oct. 7. The discussions for the ordinance have been moved to their Nov. 4 meeting but they wanted the Commission to go over it before that meeting takes place.

The ordinance is meant to put in new regulations on leashing your dog when at Wason Pond. "My thought was that it is a bit unreasonable to ask somebody who is walking their dog and wants to cool off in the water to cool off [the dog] on the leash. That was my main

concern," said Spring Hill Farm Advisory Commission member Mark Desiderio. "It was my thought that an area could be courted off. There is no such thing as 'Dog Beach' at Wason Pond, but in my mind this might become maybe named or referred to as 'Dog Beach'"

Desiderio proposed that there are several areas around Wason Pond that could be courted off for people to walk their dogs since they can't walk them on the main beach and the dogs could go in the water in these areas.

The Commission agreed to adjust the ordinance and to consider the possibility of the closed off areas for dogs. Some Commission members abstained from voting,

but the ones who did voted in favor of the new ordinance. The amended ordinance will be presented to the Selectmen at their meeting on Nov. 4.

The Commission also discussed the Ash Street Bridge and if it should be replaced or removed altogether. After a long discussion about what to do about the bridge, the Commission decided to table the discussion for their next meeting. Some Commission members will go to survey the bridge to help with their decision.

The Chester, NH Wason Pond Recreation and Conservation Area Commission will meet again for their monthly meeting on Monday, Dec. 6 at the Rangeway Meeting Room. The meeting will begin at 7 p.m.

determined that there are sight distance issues and safety concerns at the stop sign.

"The Highway Safety Committee recommends that parking be prohibited on the Easterly side of Franklin Street beginning 300-feet north of the intersection of East Broadway and continuing northerly for 240 feet to the intersection of Pearl Street."

The Council unanimously approved the ordinance.

In other news the Council had a resolution on the agenda to approve Calvary Bible Church as a polling place for the special state representative election on Dec. 7.

It was explained by Town Administrator Dave

Caron that the laws required to operate the polling place didn't align with the policies currently in the schools and thought it made sense to have it at a different place for this election.

Town Council Chairman James Morgan said that they worked hard over the past four years to have one polling location so they have consistently and it's not confusing for

people on where to vote.

He said he was disappointed that they aren't able to have it at West Running Brook Elementary School, which is where they have the past several elections.

The Council approved of the polling location with Morgan voting against it.

The next Derry Town Council meeting is slated for Nov. 16 at 7 p.m.

Chester School Board Approves Symptomatic COVID Testing

CHESTER - The Chester School Board held its regularly scheduled meeting on Nov. 3.

During the meeting one of the agenda items was in regards to Symptomatic COVID Testing.

It was explained that after last month's meeting and in response to feedback they received from the Board, they discussed adopting a new program supported by NH DPHS that will enable our nurses to administer rapid COVID antigen tests while children are in school.

It was explained that Principal Karen Lacroix, and Superintendent Sharon Locke along with interested Chester Academy parents worked together over the last month to finalize the program for Chester Academy.

"The Board very much appreciates the support and collaboration of our C-A parents on this critical issue," Chester School Board Chairman Royal Richardson said.

The initiative will be managed by the school nurses, and the testing will only be for students whose

parents have signed a permission form and develop a COVID-19 symptom during the school day.

"At its monthly meeting last night, the Chester School Board approved a new program supported by NH DPHS that will enable our nurses to administer rapid COVID antigen tests while children are in school. There is currently a nationwide shortage of test kits so testing will be provided based on availability," a letter from Lacroix and Locke following the meeting stated. "The testing will only be an option for children whose parents have signed a permission form and have developed a COVID-19 symptom during the school day and the nurse determines they may be well enough to remain at school. Students with fevers and/or multiple symptoms will continue to be dismissed from school and be required to seek a COVID-19 test or quarantine before returning."

"Participation in the symptomatic testing program is completely voluntary and requires a parental permission form," the letter went onto state. "An electronic Symptomatic COVID-19 Antigen Test Permission

Form will be sent via email early next week to parents/guardians who have completed their 2021-2022 Annual School Registration and COVID Attestation Form. If you have not yet completed this year's Registration or Attestation or are uncertain, please contact Beth Howard or Ann Parnell in the main office. Paper copies of the permission form will also be available in the main office."

Also during the meeting the School Board got an update from Locke regarding the COVID transmission level metrics which is part of the Return to School Plan.

It was explained by

Locke that the COVID transmission status in Rockingham County and the South Central Public Health Region (Atkinson, Chester, Danville, Derry, Hampstead, Londonderry, Plaistow, Salem, Sandown, Windham) remains substantial, according to the NH DHHS Dashboard.

She said that based on the state's calculation, the community of Chester is also still demonstrating substantial transmission levels. There were 11 new positive cases over the last 14 days in Chester, she noted.

It was also explained during the meeting that the Chester Academy School nurses are keeping track of

COVID symptoms that result in a student being sent home. There were 34 students presenting in the Nurses' office for nurse identified COVID Symptoms during October. There were 89 students out of school for COVID related symptoms or exposures during October.

Because of the fact that the region remains substantial and the fact that there continues to be a presence of COVID-positive cases in the school, the Board agreed that the current Universal Mask Usage policy for the Chester Academy campus should remain in effect and will be reviewed again in December.

It was also announced

during the meeting that the administration has begun working to develop a proposed budget for the 2022 - 2023 School Year with input from the Board. It was also explained that the timeline for Budget development will have the final draft of the budget delivered to the Board in late November for analysis, discussion and finalization during December. The Board will deliver the final version of the proposed Budget to the Chester Budget Committee in January for their analysis and consideration.

The next Chester School Board meeting is slated for Dec. 1 at 7 p.m.

will be using \$195,000 from the fund balance.

During the meeting, the board also discussed what they should do regarding a petition they received requesting a special meeting.

Sandown Town Administrator Lynne Blaisdell explained that they received a letter along with a petition on Oct. 26 with the question to see if the

Town would ban the use of voting machines for elections. Blaisdell said that when they received the petition they asked the Supervisor of the Checklist to determine if the signatures were valid.

She explained that at least eight signatures for the petition weren't registered voters and one was questionable because they needed their date of birth.

The requirement is to have 50 valid signatures and since they had a total

of 52 signatures it means they didn't have enough valid signatures.

"They don't have the required amount of signatures required," Blaisdell said.

After going into closed session to discuss the letter they received from legal counsel the board voted to reject the special meeting request since the petition didn't have enough valid signatures.

Also during the meeting the Board of Selectmen heard from Pat Kimball the Chairman for Sandown Old Home Day.

"I do want to thank the Town of Sandown for supporting this year's Old Home Day" Kimball said.

Kimball said that through this year's Old Home Day events they were able to raise \$1,826

which went back into the General Fund.

She said that they started the event with \$8,300 and spent \$7,737 on this year's event and now have a balance of just under \$600.

Kimball said that they are requesting a warrant article to be on the ballot during the Town Meeting for \$8,000 which would cover the cost of the 2022 Old Home Day. Kimball said that it would account for likely inflation and for them to have some more performers possibly. She noted that it wouldn't include the cost of fireworks.

Board of Selectmen Chairman Eric Olsen said that they will review the warrant article at a later date when they review the other ones.

DERRY - During the Nov. 3 Derry Planning Board meeting the Board heard an application for a lot line adjustment for 9 Hillside Avenue and 5 Hillside Avenue

It was explained by Robert Degan who was representing the owners that a variance was granted for 5 Hillside Avenue to subdivide it into two lots by the Zoning Board.

Robert Carlton who owns 9 Hillside Avenue, said at that Zoning Board meeting that they were interested in buying some of the lot at 5 Hillside Avenue in order to add onto his property

Since then the owners agreed to sell a 50 foot

strip next to Carlton pending receiving approval from the Planning Board regarding the lot line adjustment.

It was also noted during the meeting that both homes still meet with today's zoning standards even with the lot line change.

Groulx had a time of 19:14.13 and Silva finished less than a second behind her at 19:14.95. The finish was a 24-second

The Lancers were able to score in each of the four quarters that afternoon and The Astros could only score twice. The quarterfinal game finished with a 25-13 win by LHS despite being called for 13 penalties resulting in a total loss of 90-yards.

The LHS squad will now move on to the semifinals against the only team they lost to this season. The Salem High School Blue Devils won their quarterfinal match-up with Bishop Guertin by scoring a stagger-

stopped quickly by the Londonderry defense, despite a long kick return by Pinkerton junior Jacob Albert.

The Astros fourth down attempt was foiled by a Hayden Austen tackle in the backfield for a loss, giving LHS the ball at their own 33-yardline.

After another holding penalty interrupted their second drive the Lancers Heenan and Kullman combined for a huge passing play with 1:22 left in the opening quarter, Heenan completed a 61-yard unobstructed pass down the middle of the field to Kullman for the second touchdown of the game. Pinkerton had a good drive to end the first quarter and to begin the second, cutting their deficit to six-points. PA quarterback Nathan Campos completed a 13-yard pass to Logan Gokey to start the second with a TD and Picasso Bates kicked the extra point to put the game at 13-7.

Pinkerton was able to keep LHS out of the end zone in the following drive, in part by more penalties against the Londonderry offense and also with a foiled fourth down pass attempt in the end zone broken up by sophomore Caden Michaud.

The Londonderry defense kept PA to minimal yardage in their next drive and got the ball back at their

own 35-yard line with about three-minutes in the half.

Sophomore Jake Schena started that drive with a 65-yard touchdown run that was called back for a block in the back penalty.

Another pass completion from Heenan to Kullman, this time on third down and ten, resulted in a 65-yard touchdown at 1:15 in the second. Wrisley capped off the scoring in the first half with the extra point for a 20-7 Lancer lead despite nine LHS penalties.

The Pinkerton defense tightened up after the break and only gave up five points in the second half.

The first was a 23-yard field goal by Wrisly giving LHS a 23-7 lead in the third.

The Astros got the score to within 10-points to end the third quarter with a 52-yard touchdown run from Albert.

The Lancers only other points came from their defense, foiling an Albert pass attempt out of the end zone with a Michael Sampson tackle for a two-point safety.

Londonderry had 361-yards of total offense in the game and PA was held to just 230, 189 of those yards came through the air for Londonderry.

Pinkerton quarterback Nathan had 53-yards passing in six attempts and Albert ran for 53-yards in seven tries. Jack Mackierman ran for 18 yards in five plays, while Cole Yannaco carried the ball nine times for 18-yards.

With the win, Londonderry will host a semifinal game against Salem on Saturday starting at 1 p.m.

Londonderry lost to the Blue Devils 35-21 in Salem on Oct. 22, in part, due to five turnovers by interceptions and hope to correct that and the penalty issues they had in the quarterfinal win.

Senior outside hitter Lily Heywood had seven




Astros outside hitter Sarah Bolduc had 13 kills, 11 digs and one ace in the semifinals.
